Assemblyman Schofield moved for the amendment. Assemblyman Benkovich seconded the motion. Motion carried unanimously. General discussion was held. Assemblyman Schofield moved that A.B. 371 be given a "do pass" recommendation, as amended". Assemblyman Benkovich seconded the motion. All members voted "aye" except Vice-Chairman Moody, who did not vote. Motion carried.
