Chairman Banner called the meeting to order at 9:45 A.M., for the purpose of acting on A.B. 554-303-304-329-337-403-428-503-312 & 440.

## A.B. 554

Chairman Banner presented a suggested amendment (7707) to the bill.

Assemblyman Benkovich moved to adopt the amendment.

Assemblyman Moody seconded the motion.

"Aye" vote was unanimous to adopt amendment. Motion carried. Assemblyman Benkovich moved that A.B. 554 be given a "do pass" recommendation, as amended.

Assemblyman Moody seconded the motion.
"Aye" vote was Unanimous. Motion carried.

### A.B. 303

Assemblyman Schofield moved to "indefinitely postpone" the bill. Assemblyman Hayes seconded the motion.

General discussion was held.

All present voted "aye", except Chairman Banner, who voted "no". Motion carried.

### A.B. 304

John Reiser presented an amendment that had been suggested to the bill. General discussion was held, regarding S.B. 339, which is still in the Senate Committee on Commerce and Labor. It was agreed to hold up action on the bill, until the amendment could be re-drafted.

## A.B. 329

Assemblyman Getto moved to "indéfinitely postpone" the bill.

Assemblyman Moody seconded the motion.

General discussion was held. Assemblyman Schofield asked if they could postpone action on the bill, as he had a different approach to the problem, and would like to work something out, that might satisfy some of the objections to it, as it stands. Assemblyman Getto withdrew his motion.

Assemblyman Moody withdrew his second. Decided that action on bill bespostponed until a later date.

#### A.B. 337

Assemblyman Barengo suggedted that the bill be held up, until he could add a sentence after Line 6, possibly reading "Any informantion not so supplied, shall not be used by the Commission, the Appeals Officer, or their staffs, as a basis for determining awards." It was agreed that Assemblyman Barengo should work on the wording, and action on the bill should be 42postponed until a later date.

#### A.B. 403

Chairman Banner presented an amendment (7708) given him by the N.I.C. Assemblyman Benkovich read an amendment he suggested (5978) to the bill.

Assemblyman Benkocich moved to adopt both amendments.

Assemblyman Schofield seconded the motion.

"Aye" vote was unanimous. Motion carried.

Assemblyman Schofield moved that A.B. 403 be given a "do pass" recommendation, as amended.

Assemblyman Benkovich seconded the motion. "Aye" wote was unanimous. Motion carried.

# A.B. 428

Assemblyman Barengo moved that the bill be given a "do pass" recommendation.

Assemblyman Schofield seconded the motion.

General discussion was held.

Assemblyman Schofield withdrew his second.

Assemblyman Benkovich seconded the motion.

Additional discussion was held.

All present voted "aye" except Assemblymen Getto and Moody, who Voted "no". Motion carried.

# A.B. 503

General discussion was held.

Assemblyman Schofield moved to "indefinitely postpone" the bill. Assemblyman Moody seconded the motion.

All present voted "aye" except Assemblyman Benkovich and Chairman Banner, who voted "no". Motion carried.

# A.B. 440

Chairman Banner presented a proposed amendment (#5959).

General discussion was held.

Assemblyman Moody moved to adopt the amendment.

Assemblyman Benkovich seconded the motion.

All present voted "aye" except Assemblymen Benkovich, Moody, and Getto, who voted "no". Assemblyman Barengo did not vote. Assemblyman Benkovich moved that the bill be given a "do pass"

recommendation, without the amendment.

Assemblyman Moody seconded the motion.

## A.B. 440

The "aye" vote was unanimous, with the exception of <u>Assembly-man Barengo</u> who did not vote. Motion carried.

Chairman Banner announced that the remainder of the bills (namely, A.B. 312) and the ones it was agreed to hold up action on (namely A.B. 304-329 and 337), would be taken up at a later date.

Assemblyman Moody moved to adjourn the meeting. Assemblyman Benkovich seconded the motion.
