Assembly Resolution 14- Mrs. Brookman moved to Indefinitely Postpone, seconded by Mr. Mello, passed unanimously, with Mr. Jacobsen absent.

Assembly Concurrent Resolution 13- Mrs. Brookman motioned to amend page 2 line 9 to delete the word "one" and substitute the word "two". Seconded by Mr. Mello, passed unanimously with Mr. Jacobsen absent. Mr. Mello motioned to amend on page 2 by deleting brackets on lines 3 and 6 and change the word "three" to "two" on line 5. Seconded by Mrs. Brookman, passed unanimously with Mr. Jacobsen absent. Mr. Mello then motioned to amend page 2 by deleting lines 13 through 16. Seconded by Mrs. Brookman, passed unanimously, with Mr. Jacobsen absent. Mr. Mello then moved to DO PASS, seconded by Mrs. Sena, passed unanimously with Mr. Jacobsen absent.

Assembly Concurrent Resolution 15- Mrs. Brookman moved a DO PASS, seconded by Mrs. Wagner, passed unanimously with Mr. Jacobsen absent.

Assembly Concurrent Resolution 10- Mr. Bennett moved to Indefinitely Postpone, seconded by Mr. Mello, passed 5 to 1 with Mrs. Wagner: voting "no" and Mr. Jacobsen absent.
