#### LEGISLATIVE FUNCTIONS - NEVADA STATE LEGISLATURE - 58TH SESSION

#### MAY 14, 1975

The meeting was called to order at 4:05P.M. by Chairman Dreyer.

SPEAKING GUESTS: Assemblyman Bob Weise

Pete Kelly, Nevada Retail Association

AB 790 Mr. Bob Weise spoke in favor of this bill. He explained that this bill was to stop the excessive lobbying on state money of state employees. He added that testifying in committees was fine but just plain lobbying and observing was not what the state paid their employees to do.

Mr. Jacobsen asked how this provision was to be enforced. Mr. Weise answered that upon the beginning of the session, the state employees would be reminded of the provision and the embarrassment of being recognized in the chambers would probably be enough of a deterrent.

Mr. Sena asked if this action could be done by an administrative rule instead of legislative. Weise answered that it could.

ACR 74 Mr. Pete Kelly of the Nevada Retail Association spoke in favor of this resolution. Mr. Jacobsen asked if Mr. Kelly though that this could be an in-house study done by the Legislative Counsel Bureau, Mr. Kelly answered that he thought the information available in Carson City would be sufficient to do the study. Mr. Mello moved a DO PASS on ACR 74, seconded by Mr. Jacobsen, passed unanimously with Mr. Bennett and Mrs. Wagner absent.

ACR 71 Mr. Pete Kelly also spoke in favor of this resolution.

He said that NIC has a monopoly on worker's compensation insurance and that it would probably be cheaper with more benefits if other insurance agencies could write that kind of insurance.

Mr. Mello and Mr. Jacobsen commented that money could be saved by having other insurance companies write insurance along with the other policies businesses have. Mr. Mello moved a DO PASS, seconded by Mrs. Brookman, passed unanimously.

SENATE AMENDMENT TO AB 735 - the committee decided to concur in the senate amendment.

AR 30 Mr. Mello said he didn't know why they should pay the Chief Clerk of the Assembly per diem if she lived in Carson City.

Mr. Mello made a motion to Indefinitely Postpone AR 30, seconded by Mr. Jacobsen, motion defeated with only Mr. Mello and Mr. Jacobsen voting in favor of the motion.

Mr. Mello then moved to rerefer the resolution to Ways and Means, seconded by Mr. Jacobsen, motion died 3-3 with Mr. Sena not voting, Mrs. Wagner, Mr. Dreyer and Mr. Bennett voting against the motion.

Mr. Bennett moved a DO PASS, with Mrs. Wagner seconding the motion. Mr. Mello and Mrs. Brookman moved to amend that motion to DO PASS WITHOUT RECOMMENDATION, that motion passed unanimously.

Mrs. Wagner moved that the committee rescind its action whereby it passed AR 30 for purposes of amendment, seconded by Mr. Jacobsen. Passed unanimously.

Mrs. Wagner moved that the bill be amended to say that beginning with the 1977 session, the chief clerk will be paid per diem if the chief clerk lives outside of Carson City. Seconded by Mr. Sena, passed 6-1 with Mr. Mello voting no.

Mr. Jacobsen motioned a DO PASS AS AMENDED \*\*Imotion amended by Mello to read DO PASS AS AMENDED WITHOUT RECOMMENDATION, motion seconded by Mrs. Wagner. Passed 6-1 with Mr. Mello voting against his motion.

AB 629 Mr. Mello moved to INDEFINITELY POSTPONE, seconded by Mr. Jacobsen, after discussion passed 4-3 with Mr. Sena, Mrs. Wagner and Mr. Bennett voting against the motion.

AB 790 Mr. Jacobsen motioned to DO PASS motion died for lack of a second.

Mr. Sena moved to INDEFINITELY POSTPONE, seconded by Mr. Bennett, motion passed with Mr. Jacobsen voting no, and Mr. Mello, Mrs. Wagner and Mrs. Brookman not voting.

ACR 76 Mr. Jacobsen moved to INDEFINITELY POSTPONE, Seconded by Mr. Bennett, motion passed with Mrs. Wagner and Mrs. Brookman voting no.

The committee discussed end of the session gifts out of the funds collected by the legislators. Final decisions of amounts and persons to receive gifts will be attached later.

There being no further business, the meeting adjourned at 5:30.
