

MINUTES

WAYS AND MEANS COMMITTEE - NEVADA STATE LEGISLATURE - 58th SESSION

May 2, 1975

The meeting was called to order at 8:00 A.M. by Chairman Mello in the Ways and Means Committee Room.

PRESENT: Chairman Mello, Mrs. Brookman, Mr. Dreyer, Mr. Glover, Mr. Howard, Mr. Weise and Mr. Wittenberg. Mr. Bremner and Mr. Robinson were excused.

ALSO PRESENT: Bill Bible, John Dolan, Peter Simon, Senator Lamb, and Bill Hancock.

Chairman Mello stated that he met with Senator Lamb and is making the following recommendations to the committee:

- Secretary of State Archives - Go with Assembly
- Supreme Court - Mr. Glover and Mr. Weise were appointed to a sub-committee to look further into this budget.
- University of Nevada Reno - Go with Assembly and delete One-Shots
- Desert Research Institute - Go with Senate
- Clark County Community College - Go with Senate
- Aging Services - Go with Assembly
- Rural Clinics - Go with Senate
- ✓ Rehabilitation Division Administration - Go with Senate in deleting two existing and two new positions.
- Regional Plumbing Boards - Go with Assembly
- Division of State Parks - Go with Assembly

- 75-14 Lighting Capitol Complex - Go with Assembly
- 75-15 Snow Melting - Blasdel Building - Go with Assembly
- 75-32 Go with Senate, but at a total cost of \$336,000
- 75-37 Athletic Field, UNLV - Go with Senate
- 75-43 Agriculture Office, Las Vegas - Go with Senate
- 75-45 Agriculture Laboratory, Elko - Go with Senate
- 75-46 Storage, Northern Nevada Childrens Home - Go with Senate and Assembly and reduce project \$20,000
- 75-51 Parking, UNLV - Go with Senate

- Fort Churchill - Go with Senate
- Washoe Lake - Go with Senate

Mr. Wittenberg made a motion to approve the action taken by Chairman Mello and Senator Lamb. Mr. Glover seconded. Motion passed.

Senator Lamb stated that he has talked with Jim Cashman and Bill Flangas and they are in accord with the Jean site. Senate Finance made a motion that "approval of the Jean, Nevada site be made and Peter Simon be subject to a Performance Bond in the amount of \$500,000. The legal work be completed by July 1, 1975 and the construction work be done by January 1, 1976. Legislative Procedure will be called to find an alternate site if Jean is not feasible." Senator Lamb stated that a little leeway should be given on the January 1, 1976 deadline. A second motion made by Senate Finance was "If Jean, Nevada site is not feasible, any alternate will be subject to approval by the Interim Finance Committee."

Mr. Weise made a motion to concur with the Senate in the location of the Correctional Center and the motions made by Senate Finance. Mr. Wittenberg seconded. Motion passed.

AB 224 "Provides for stratified depreciation of mobile homes for property tax assessment purposes." BDR 32-587.

Mr. Weise made a motion to amend this bill to include \$15,000 in the first year and \$35,000 in the second year. Mr. Dreyer seconded. Motion passed. Mr. Weise made a motion to recommend a "Do-Pass" as amended. Mr. Dreyer seconded. Motion passed.
