Assemblyman Mello asked how many states belong. Mr. Bible said that 45 States and two territories belong. Assemblyman Mello said that it sounds like Nevada is 'burying her head in the sand'. Senator Gibson said that even if the State was denied the publications, they would be allowed to attend the meetings.

Senator Lamb said that this is the fastest growing area in education and shouldn't be reduced. Mr. Dolan said that the re-construction of the budget was not an attempt to cut down, but just start with a fresh approach. Mr. Howard Barrett gave the following information on Spring Enrollment:

Elko campus -- Same enrollment as in the Fall. Western campus -- About 200 less than in the Fall. Clark campus -- 2,100 Fall enrollment, 2,500 Spring enrollment

Mr. Barrett recommended that 200 more FTE's be allowed for Clark County, and the cost for this will be \$105,091 for the first year,

and \$116,640 for the second year. Assemblyman Mello said that their Committee wanted to know exactly what the money was for as staff has been added in the past, and after the fact approval was asked for the position by the Legislature. Mr. Dolan said that the intent was to get the budget self-contained. Assemblyman Mello said that a letter of intent should be sent making it clear that if System Service funds are to be used for hiring, it should be for instructional positions only.

#### WICHE:

Assemblyman Robinson said that if the money was not used for these additional slots, it would not revert, but would be held over, and he added that the annual cost of \$300,000 is less than the operating cost for a law school. Assemblyman Robinson also said that this program would ensure that the money will be spent on just Nevadans, as a law school would be for out-of-state students as well.

Senators Gibson and Brown felt that WICHE should have some criteria for need. Assemblyman Robinson said that WICHE only pays a base cost and the difference in tuition is payed by the student.

Assemblyman Mello said that the two existing Personnel positions were reinstated. Assemblyman Weise said that neither one of the individuals filling these positions were really personnel officers. Senator Raggio asked how does this happen. Mr. Barrett said that the agency provides documentation that this is the work that the individual is doing. There was some general discussion on the numerous reclassifications that may not be justified, and Assemblyman Weise said that 41 out of 178 reclassifications have been in this department alone.

### Vocational Rehabilitation:

### Services to the Blind:

Assemblyman Glover said that the Mobility instructor teaches the blind people how to perform necessary daily functions.

Assemblyman Robinson said to delete any positions would create additional problems in an agency that is already understaffed.
