The meeting was called to order at 9:15 a.m.

AB 211

Senator Lamb distributed amendments on this bill to the Committee. Senator Lamb said that it has been decided that the increase will be 15% for the first year, with 4% and a trigger device if the revenue increases accordingly.

Mr. Ron Sparks said that \$310,000 is 1/2 cost of 1% of the Cost of Living Raise, and this was measured by the last quarter of 1975, and the first quarter projection of 1976. Senator Brown said he did not see why the trigger device was necessary. Senator Lamb said that this was the least in the compromise he could come out with. Senator Brown said that he could go for 15% and 4% without the trigger. Senator Brown questioned if there was any consideration of ADC or the Distributive School Fund. Senator Gibson said that with this proposal, the appropriations would be \$1.3 million over the Governor's budget. Senator Raggio asked if this amount included the unclassified pay raise. Senator Gibson said no. Senator Walker asked if the proposed increase in ADC would increase this \$1.3 million. Senator Lamb said yes. Mr. Sparks said that currently the budget has a surplus of between \$20 million and \$22 million, but many fiscal bills are still out.

There was some discussion as to whether this proposal would be accepted on the floor. Senator Lamb felt that he did not want a caucus prior to a floor presentation. It was decided that the proposal would be taken to the floor for a vote.

SB 265

Senator Gibson questioned the amendments distributed by Mr. Sparks, and suggested that this be further studied, before a vote is taken.

SB 448 (See attached bill)

This was a vote on amendments to this bill.

Senator Young asked what affect will any adjustments in this bill have on the budget. Mr. Sparks said approximately \$100,000.


AB 210


Senator Lamb asked if the Committee wished to re-consider this bill. The Committee decided negatively on this question.

SENATE BILL NO. 448—SENATORS RAGGIO, YOUNG,
FOOTE, GOJACK AND WILSON

APRIL 3, 1975

Referred to Committee on Finance

SUMMARY—Makes appropriation for capital improvements on land used for
Nevada State Fair. Fiscal Note: Yes. (BDR S-1503)

EXPLANATION—Matter in *italics* is new; matter in brackets [] is
material to be omitted.

AN ACT relating to the Nevada State Fair; making an appropriation to Nevada State Fair, Inc., a nonprofit organization, for capital improvements to the fair grounds.

- 1 WHEREAS, The Nevada State Fair is conducted annually on land owned
2 by the State of Nevada and held on a long-term lease by Washoe County;
3 and
4 WHEREAS, The fair has been carried on for many years by the Nevada
5 State Fair, Inc., a nonprofit organization, which in past years has contrib-
6 uted large sums of money for construction of facilities and improvements
7 on the fair grounds; and
8 WHEREAS, The sum of \$100,000 is presently required for additional
9 capital improvements for the fair grounds; now, therefore,
10
11 *The People of the State of Nevada, represented in Senate and Assembly,*
12 *do enact as follows:*

14 SECTION 1. 1. There is hereby appropriated from the state general
15 fund the sum of \$100,000 to the board of directors of Nevada State Fair,
16 Inc., for the purpose of making capital improvements to the fair grounds
17 located in Washoe County, Nevada.
18 2. No portion of the moneys appropriated in subsection 1 may be
19 released by the state board of examiners until the state board of examiners
20 receives satisfactory proof that the board of directors of Nevada State
21 Fair, Inc., has received the sum of \$100,000 from other public and pri-
22 vate sources for the specific purpose of making capital improvements to
23 the fair grounds located in Washoe County, Nevada.
24 SEC. 2. This act shall become effective upon passage and approval.
