SB17 - Provides that restitution may be made a condition of probation or parole.

The Bill, introduced by Senator Sheerin, is for the purpose of benefiting the victim of a crime by providing that some monetary restitution is made for the loss of property.

Senator Wilson moved a "do pass" on the Bill.

Seconded by Senator Bryan.

Motion carried unanimously with one amendment on line 38, removing the word "restitory" and including proper verbiage.

The compilation of Nevada laws which might be subject to change if the ERA is adopted, was next taken under consideration. Chairman Close explained it was their intention to discuss the first 15 pages and take proper action on each section, individually.

Mr. Bill Isaeff advised the Committee members that there are other Nevada laws that will, or may, require revising and his office will submit a supplemental list for their review prior to final action being taken.

The following items were discussed and recommendations made:

127.040 - No change.

125.040 - Amend to make reciprocal. Motion to amend moved by Senator Bryan, seconded by Senator Wilson. Motion carried unanimously.

125.060 - No action at present. Hold for further study.

125.130 - Motion for amendment made by Senator Bryan. Seconded by Senator Wilson. Motion carried unanimously.

End of discussion on legislation involved with E.R.A.

The Nevada Gaming Control Board requested a bill clarifying and expanding provisions of their Act. The request was introduced and explained by Senator Bryan.

After brief discussion, a motion was introduced by Senator Dodge that the Committee forward this bill for introduction.

Seconded by Senator Wilson.

Motion carried unanimously.

Chairman Close advised the Committee he has received a request by the Narcotics Division for a bill providing for prescriptions for narcotics to be made in triplicate, with their agency receiving one copy. He has since learned that the druggists are very much against this type of legislation.

A motion was made and seconded for introduction of this bill. Motion carried unanimously.

There being no further business, the meeting was adjourned. Meeting will be held January 29, 1975 at 9:30 a.m.
