Chairman called the meeting to order in the Assembly Lounge for the purpose of hearing and taking action on AB 686 and SB 353.

AB 686, Limits number of terms trustee of school district may serve.

Dale Goodman, sponsor of the bill, spoke in favor of the bill. He stated that he would actually like to see this apply to all elected officials.

Mr. Goodman moved for a "do pass". The motion died for lack of a second.

Mr. Goodman then moved for "indefinite postponement" and Mrs. Wagner seconded the motion. The motion carried with Mr. Goodman voting against the motion and Mr. Chaney and Mr. Sena absent at this time.

SB 353, Adds explanations of statewide measures to matter prescribed for inclusion in election ballots and in official publication of measures in newspapers.

Mr. Mann stated that this basically would allow the Secretary of State to draw up uniformly the propositions that will go on the ballot. He stated that he had been advised that the Secretary of State could do this within his proposed budget.

Mrs. Wagner added that this would be in easily understood language.

Mrs. Wagner moved for a "do pass" and Mr. Kosinski seconded the motion. The motion carried unanimously with Mr. Sena absent.

Mr. Kosinski then stated that he would like to present his report on postcard registration. Mr. Mann stated that he would call for that report at the next meeting. Meeting was adjourned.
