AB 268: Mrs. Hayes moved for a Do Pass as Amended. Mr. Sena seconded the motion and it carried unanimously. (Mr. Coulter and Mr. Price were not in the room at this time.)

AB 209: Mr. Ross moved for a Do Pass as Amended. Mr. Sena seconded the motion and it carried unanimously.

AB 375: Mr. Ross moved for a Do Pass as Amended. Mr. Sena seconded the motion and it carried unanimously.

AB 423: Mrs. Wagner moved for an Indefinite Postponement. Mr. Ross seconded the motion and all members voted yes, except Mr. Coulter who abstained.

AB 418: This bill was deferred until the committee has heard AB 476 which includes this bill within it.

AB 366: Mrs. Hayes moved for a Do Pass. Mr. Sena seconded the motion and it carried unanimously.

AB 311: Mr. Ross moved for an Indefinite Postponement. Mrs. Hayes seconded the motion and after a discussion on this it was decided that the committee rules would be amended to include a provision for swearing in the witnesses before testimony. A sign will be placed in the committee room which will read: "Pursuant to NRS 218.535, this is a formal hearing of the Nevada State Legislature and every person who appears will be sworn before giving testimony."

AB 63: Mr. Coulter moved for a Do Pass as Amended. Mrs. Wagner seconded the motion and it carried unanimously.
