MINUTES

LABOR AND MANAGEMENT COMMITTEE March 15, 1977

Chairman Banner called the meeting to order at 3:20 p.m., and stated the purpose of the meeting was to take action on A.B. 20, 69, 70, 176, 180, 181, 281 and 302. Since there were amendments to A.B. 20 and 70, it was agreed to start with A.B. 176.

ASSEMBLY BILL 176

Mr. Goodman moved for an Indefinite Postponement, seconded by Mrs. Gomes, and passed by the committee with Mr. Weise voting no.

ASSEMBLY BILL 180

Mr. Goodman moved for an Indefinite Postponement, seconded by Mrs. Gomes, which was unanimously passed.

ASSEMBLY BILL 181

Mr. Weise presented an amendment to the bill to the effect that if a person is laid off early in the week and his pay is less than he would receive as his weekly benefit, that week will count as his waiting week for unemployment compensation. This would eliminate all the time lag problems. Mrs. Gomes asked why the bill was necessary at all if it eliminates part of the waiting week. However, Mr. Weise said it would still save between \$2 and \$4 million.

Mr. Robinson moved for the adoption of Amendment 297A, seconded by Mr. Weise, and unanimously passed.

Mr. Robinson moved for a Do Pass as Amended, seconded by Mr. Weise. Mr. Goodman stated he was against the bill because it only penalizes the person who returns to work before receiving all of his unemployment compensation benefits. The bill passed as amended with Mr. Goodman, Mrs. Gomes and Chairman Banner voting no.

ASSEMBLY BILL 20

Chairman Banner stated there was an amendment to the bill which would delete the present Sections 1 to 5, and insert a new Section 1 setting forth conditions for reporting industrial accidents by Ex-medical employers. Mr. Weise moved for adoption of Amendment 19A, seconded by Mr. Dreyer, and unanimously passed. Mr. Weise then moved for a Do Pass as Amended, seconded by Mrs. Gomes, which passed unanimously.

ASSEMBLY BILL 69

Mr. Robinson moved for an Indefinite Postponement, seconded by Mr. Weise. Mr. Robinson explained that the bill was objectionable to both labor and management as written, and he personally objected to the use of the word "shall" throughout. Lou Paley, representing Nevada State AFL-CIO, and speaking on behalf of Labor Commissioner Stan Jones who could not be present, asked the committee to hold the bill for amendments which Mr. Jones wished to present. However, Mr. Weise stated that from the letters Mr. Jones read at the hearing on the bill, the mediation system was working well without the need for this bill, and the committee voted to indefinitely postpone it with Mr. Goodman, Mrs. Gomes and Mr. Banner voting no.

ASSEMBLY BILL 70

Mr. Banner stated there were two amendments to this bill, Amendment 89A which would eliminate the problems for hotel workers, and 227A which would provide for an 80-hour two-week workweek for employees of hospitals. Mrs. Gomes moved for adoption of Amendment 89A, seconded by Mr. Robinson, and unanimously passed. Mrs. Gomes moved for adoption of Amendment 227A, seconded by Mr. Dreyer, and unanimously passed.

Mr. Weise said there should be a third amendment and moved to delete lines 33 and 34 on page 2, seconded by Mrs. Gomes and unanimously passed. Mr. Weise is to have the amendment prepared.

Mr. Dreyer moved for a Do Pass with the three amendments, seconded by Mr. Bennett, and passed unanimously.

ASSEMBLY BILL 281

Mr. Dreyer moved for a Do Pass, seconded by Mr. Weise, which passed unanimously.

ASSEMBLY BILL 302

Mr. Weise moved for an Indefinite Postponement, seconded by Mr. Robinson, which passed with Mrs. Gomes, Mr. Goodman and Mr. Banner voting no.

There being no further business, the meeting was adjourned at 3:49 p.m.
