AB 285

Mr. Don Crosby, Deputy Engineer, Highway Department spoke in favor of AB 285. For the past two years the magazine known as Nevada Highways and Parks, has been published by the Department of Economic Development, which is making a presentation to receive general funding. The Highway Department agrees with this approach.

AB 286

Mr. William Engles, Department of Highways, stated this bill was initiated to assist in collecting the data by surveys necessary to develop construction projects. They have had to delay two projects because private property owners denied access for the archeologists to make the necessary surveys to determine the magnitude of what they consider to be archeological finds. It is possible the Federal Govment will not accept impact statements on a project that does not satisfy that particular part. The attorneys for the Department has told them they do not presently have the authority to conduct archeological surveys without the consent of the property owner. environmental impact statement is very complicated and the archeological data is one of the elements they have to address. Qualified people have to make an on the sight inspection to determine if there are archeological matter that should be considered.

Mr. Glover moved to Do Pass AB 285 and put it on the Consent Calendar. Mr. Demers seconded the motion; motion carried unanimously.

Mr. Demers moved to Do Pass AB 286; Mr. Harmon seconded the motion; motion carried unanimously.
