SB 57

Mr May moved to indefinitely postpone SB 57; Mr. Glover seconded the motion

A brief discussion followed.

Mr. May called for the question; Mr. Glover, Mr. Harmon, Mr. May, Mr. Jacobsen and Mrs. Westall voted "aye"; Chairman Hayes voted "no"; motion carried.

AB 15

Chairman Hayes stated this bill had been held for subsequent bill SB 57, which if passed would have an impact on AB 15. The Committee agreed to let the action of February 3, pertaining to AB 15, stand.

AB 358

Mr. Glover moved to indefinitely postpone AB 358; Mr. Harmon seconded the motion; motion carried unanimously.

AB 397

Mr. Harmon moved to adopt the amendment discussed 3-10, Exhibit "H" The amendment reads as follows:

Following wording should be added after the period line 12, page 2 of AB 397.

"All license plates and registration certificates shall be turned in to the department before any credit can be allowed."

Mr. Glover seconded the motion; motion carried unanimously.

Mr. Harmon moved to Do Pass AB 397 as amended; Mr. Glover seconded the motion; motion carried unanimously.

AB 370

Mr. Jacobsen moved to Do Pass AB 370; Mr. Harmon seconded the motion; Chairman Hayes, Mr. Harmon, Mr. May, Mr. Jacobsen, Mrs. Westall voted "aye"; Mr. Glover voted "no".

Chairman Hayes announced there would be a rehearing set for AB 21.

Chairman Hayes requested Mr. Harmon take care of the amendment to AB 397; Mr. Harmon agreed to do so, and to handle the measure on the floor of the Assembly.
