# EDUCATION, HEALTH, WELFARE & STATE INSTITUTIONS

### JANUARY 20, 1977

The meeting was called to order in Room #323 at 8:05 a.m. on Thursday, January 20, 1977, with Senator Jack Schofield in the Chair.

Chairman Schofield opened the meeting with a discussion of each member's right to committee input and participation. Chairman Schofield also questioned each member as to whether they had visited the educational, welfare, mental, and reform institutions throughout the State. The Chairman emphasized the need to visit the facilities for these areas as soon as possible, as a total committee function. Chairman Schofield proposed a tentative schedule for the Reno, Elko, and Las Vegas (Caliente) divisions.

Chairman Schofield introduced the proposed Committee Rules (Exhibit A). Senator Blakemore moved for adoption. Senator Neal requested an individual reading prior to adoption.

Senator Hernstadt suggested that Rule #3 should be re-written. Chairman Schofield agreed that the last sentence of #3 was redundant, and should be omitted.

Senator Neal questioned the purpose of Rule #6. Senator Blakemore replied that later during the session when the Committee is dealing with numerous bills, this will cause less "stampeding" of legislation.

Senator Neal questioned if Rule #8 meant that no votes will be held during the open meetings of the Committee. Senators Schofield and Blakemore said that this was really inserted to avoid confusion and embarrassment if the members were in conflict over an issue. Senator Neal stated that all members should be ready to vote or abstain as soon as testimony is completed.

Senator Neal: Motion to delete Rule #8
Senator Hernstadt: 2nd the Motion



Senator Blakemore said in discussion of this Motion that he agreed this could be left up to the discretion of the Chairman.

The Motion passed.

Chairman Schofield then asked if the Committee had any additions to the proposed rules. Senator Neal questioned why the Committee members themselves could not move on a question. Senator Blakemore said that this should be left to the Chairman to 'entertain' a motion in order to avoid confusion. Senator Neal felt that Rule #7 was not in accord with Mason's Manual, and conflicted with Rule #2. Chairman Schofield suggested that the discussion on Rule #7 be set aside until the next meeting.

Senator Neal: Motion to approve rules #1 thru #6 with amendment to #3 and #8 as voted on.
Senator Hernstadt: 2nd the Motion

The Motion passed.

Chairman Schofield entertained the motion to adopt the BDR's (Exhibit B) in total, as Committee introductions.

Senator Blakemore: Motion to approve the BDR's as Committee introductions. Senator Hernstadt: 2nd the Motion The Motion passed.

Mr. John Gamble extended an invitation to the Committee to visit the Department of Education in Carson City. Ms. Susan Haase of N.A.R.C. also invited the Committee to visit the local workshops for the mentally retarded. Senator Blakemore suggested that it might be interesting for the Committee to sit in on a State Board of Education meeting. Mr. Gamble said there would one held in Carson City in the month of March.

Chairman Schofield adjourned the meeting at 8:50 a.m.

PROPOSED COMMITTEE RULES -- Note that this is the original proposition and the adopted Rules are Exh."C"

- 1. Four members constitute a quorum of the committee.
- 2. Motions will be moved, seconded, and passed by a simple majority of those present, except that disposable action ("Do Pass" or "Hold") on a bill will require a majority of the entire committee.
- 3. In order to reconsider previous action taken, an affirmative vote of two-thirds of a full committee (4) will be required. However, a majority may allow the hearing of new evidence or information which would be pertinent to the determination of whether or not a matter or an action should be re-considered.
- 4. Mason's Manual will be followed as to parlimentary procedure.
- 5. Any member of the committee may request an item on the agenda by contacting the committee chairman a day ahead of the committee meeting.
- 6. Committee bill introduction will be only by approval of four (4) committee members. Committee introduction does not imply in any way a commitment on the part of any committee member to support the bill introduced.
- 7. Motions for disposable action by the committee will be taken only at the call of the chairman or in accordance with Rule 5 above. Such votes will be recorded in the minutes of the meeting.
- No committee action on bills, budgets or resolutions during a hearing.
