MINUTES OF MEETING

April 12, 1977

The meeting was called to order by Chairman Mello at 4:00 p.m.

PRESENT: Chairman Mello, Mr. Bremner, Mrs. Brookman, Mr. Hickey, Mr. Howard, Mr. Glover, Mr. Kosinski, Mr. Rhoads, Mr. Serpa, Mr. Vergiels, Senator Lamb, Senator Hilbrecht, Senator Gibson, Senator Glaser, Senator Wilson and Senator Young.

ALSO PRESENT: John Dolan, Assembly Fiscal Analyst; Ron Sparks, Senate Fiscal Analyst; Howard Barrett, Budget Division and Bill Bible, Budget Division.

OFFICE OF THE GOVERNOR (Page 2). There are no differences between the Senate Finance Committee and the Ways and Means Committee except for the fact that Ways and Means does not as yet have the bill.

MANPOWER SERVICES COUNCIL (Page 10). Mr. Howard made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Rhoads. Motion passed.

LIEUTENANT GOVERNOR (Page 16). Ways and Means voted to stay with the Governor's Recommendation and Senate Finance voted to stay with the removal of the half-time contract secretary.

SECRETARY OF STATE - ARCHIVES (Page 29). There is no difference between Ways and Means and Senate Finance except for the fact that S.B. 87 is sitting in Assembly Government Affairs.

PERSONNEL ADMINISTRATION (Page 42). No action was taken.

BOARD OF PARDONS COMMISSION (Page 124). There are no differences between Ways and Means and Senate Finance except for the fact that Ways and Means has not received S.B. 424.

RETIRED JUSTICE DUTY FUND (Page 132). Mr. Howard made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Kosinski. Motion passed.

JUDICIAL SELECTION AND DISCIPLINE COMMISSION. No action was taken.

DEPARTMENT OF EDUCATION ADMINISTRATION (Page 136). No action was taken.

DISTRIBUTIVE SCHOOL FUND (Page 140). No action was taken.

ARCHEOLOGICAL SURVEY (Page 260). Mr. Sparks stated that Senate Finance amended S.B. 359 which establishes a new division in the Department of Conservation and Natural Resources entitled the Division of Historic Preservation and Archeology. Within that bill, The Committee appropriated \$75,000 as a "one-shot" for creation of a revolving fund to be used for archeological services within that Division. The only additional General Fund money that would be needed to create this Division beyond what has been recommended in

the Historic Preservation Program is approximately \$24,000 each year. Senate Finance has indefinitely postponed the separate Archeological Survey budget and has in its place created a Division of Historic Preservation and Archeology.

Mr. Glover made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Howard. Motion passed.

BUREAU OF COMMUNITY HEALTH SERVICES (Page 286). Senator Gibson made a motion that Senate Finance concur with Ways and Means; seconded by Senator Hilbrecht. Motion passed.

DRINKING WATER PROGRAM (Page 306). Senator Gibson made a motion that Senate Finance concur with Ways and Means; seconded by Senator Hilbrecht. Motion passed.

INCREASE HEALTH AID TO COUNTIES (Page 315). Senator Hilbrecht made a motion that Senate Finance concur with Ways and Means; seconded by Senator Young. Motion passed.

DIVISION OF MENTAL HYGIENE/MENTAL RETARDATION (Pages 328-389). Senator Young made a motion that Senate Finance concur with Ways and Means; seconded by Senator Hilbrecht. Motion passed.

COMMUNITY TRAINING CENTER FUND (Page 390). Senator Glaser made a motion that Senate Finance concur with Ways and Means; seconded by Senator Young. Motion passed. (Senator Lamb voted no.)

WELFARE ADMINISTRATION (Page 398). Mr. Serpa made a motion that Ways and Means concur with Senate Finance on salary savings; seconded by Mrs. Brookman. Motion passed.

Senator Hilbrecht made a motion that Senate Finance concur with Ways and Means as to the Child Care Service Officer, operating and travel; seconded by Senator Young. Motion passed. (Senator Gibson, Senator Lamb and Senator Wilson voted no.)

ASSISTANCE TO THE AGED AND BLIND (Page 405). Mr. Howard made a motion that Ways and Means concur with Senate Finance regarding the change in calculation for Food Stamps for the Blind; seconded by Mr. Hickey. Motion passed.

Senator Gibson made a motion that Senate Finance concur with Ways and Means regarding increased payments to Adult Group Care Facilities; seconded by Senator Echols. Motion passed.

HOMEMAKING SERVICES (Page 410). Senator Glaser made a motion that Senate Finance concur with Ways and Means; seconded by Senator Echols. (Motion failed 3-4.)

FOOD STAMP PROGRAM (Page 412). Mr. Howard made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Kosinski. Motion passed. (Mrs. Brookman voted no.)

NEVADA YOUTH TRAINING CENTER (Page 465). Senator Gibson made a motion that Senate Finance concur with Ways and Means; seconded by Senator Hilbrecht. Motion passed.

YOUTH PAROLE - BOYS SCHOOL (Page 469). Senator Young made a motion that Senate Finance concur with Ways and Means; seconded by Senator Glaser. Motion passed. (Senators Gibson, Lamb and Wilson voted no.)

DIVISION OF CHILD CARE SERVICES (Page 493). Senator Young made a motion that Senate Finance concur with Ways and Means; seconded by Senator Glaser. Motion passed. (Senators Gibson, Lamb and Wilson voted no.)

BANKING DIVISION (Page 597). Mr. Howard made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Vergiels. Motion passed.

SAVINGS AND LOAN DIVISION (Page 600). Senator Glaser made a motion that Senate Finance concur with Ways and Means; seconded by Senator Young. Motion passed.

77-16 Mr. Howard made a motion that Ways and Means concur with Senate Finance; seconded by Mrs. Brookman. Motion passed. (Mr. Glover, Mr. Vergiels and Mr. Serpa voted no.)

77-28 Senator Young made a motion that Senate Finance concur with Ways and Means; seconded by Senator Glaser. Motion passed. (Senators Echols, Gibson and Lamb voted no.)

77-49 Mr. Kosinski made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Rhoads. Motion passed. (Mr. Glover, Mr. Vergiels, Mrs. Brookman and Mr. Hickey voted no.)

77-57 Mr. Kosinski made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Hickey. Motion passed. (Mr. Serpa, Mr. Glover, Mr. Vergiels and Mrs. Brookman voted no.)

NEW PROJECT: Provide Facility for 6 additional dental chairs for Clark County Community College.

Mr. Vergiels made a motion that Ways and Means concur with Senate Finance; seconded by Mrs. Brookman. Motion passed.

77-73 Senator Gibson made a motion that Senate Finance concur with Ways and Means; seconded by Senator Young. Motion passed. (Senator Hilbrecht voted no.)

77-81 Senator Glaser made a motion that Senate Finance concur with Ways and Means; seconded by Senator Young. Motion passed. (Senator Hilbrecht voted no.)

STORAGE, BUILDING, BOYS SCHOOL - \$231,000. Senator Glaser made a motion that Senate Finance concur with Ways and Means. Motion failed for lack of a second.

Mr. Glover made a motion to delete the project and that Ways and Means concur with Senate Finance; seconded by Mr. Vergiels. Motion passed. (Mr. Rhoads and Mrs. Brookman voted no.)

ELEVATOR - NYE BUILDING - \$102,000. Senator Gibson made a motion that Senate Finance concur with Ways and Means; seconded by Senator Echols. Motion passed 4-3.

FENCING, GOVERNOR'S MANSION - \$12 500. No action was taken.

STATE MOTOR POOL, LAS VEGAS - \$211 750 general funds - \$71,250 highway funds. No action was taken.

PARK IMPROVEMENTS (Page 793).

BERLIN-ICHTHYOSAUR. Mr. Glover made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Howard. Motion passed. (Mrs. Brookman voted no.)

ECHO CANYON. Mr. Glover made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Howard. Motion passed.

BOUNDARY SURVEYS. Mr. Serpa made a motion that Ways and Means concur with Senate Finance; seconded by Mr. Glover. Motion passed.
