The first order of business, to discuss scheduling of bills that were to come before the Government Affairs committee. The following were considered for committee introduction.

BDR-19-334

An Act relating to meetings of state and local agencies; clarifying the provisions and exceptions of the open meeting law by removing duplicative statutory language; and providing other matters properly relating thereto.

Motion for Committee introduction by Senator Raggio, seconded by Senator Hilbrecht. Motion carried unanimously.

BDR-S-298

An Act relating to local government; repealing chapters 648, 649 and 697, and part of chapter 750, Statutes of Nevada 1975; and providing other matters properly relating thereto.

Motion for Committee introduction by Senator Hilbrecht, seconded by Senator Faiss. Motion carried unanimously.

BDR-20-491

An Act relating to county officers and employees; permitting counties to provide for annual leave and sick and disability leave by collective bargaining agreement; requiring that an ordinance or agreement on such leave include a provision for partial carrying forward of unused sick leave after the accumulation of 90 days, and authorizing a provision on use of sick leave accrued but not carried forward; and providing other matters properly relating thereto.

BDR-20-492

An Act relating to county officers and employees; permitting counties to provide for an additional accumulation of unused sick and disability leave to be used for long-term or chronic illness or an injury and providing other matters properly relating thereto.


