The seventh meeting of the Senate Legislative Functions Committee was called to order at 2:08 p.m.

Chairman Echols noted that Senators Schofield and Raggio had been excused. Senator Close absent from meeting.

ACTION WAS TAKEN ON THE FOLLOWING BILLS:

SR 10

Changes names of certain standing committees of Senate.

After noting that the change would parallel regional, western and national titles,

Senator Wilson moved "BE ADOPTED" Senator Gojack seconded Motion carried unanimously.

AB 235

Requires Legislative Counsel to prepare statutory tables for Statutes of Nevada.

Art Palmer explained that this bill merely complies with present practice.

Senator Wilson moved "DO PASS" Senator Gojack seconded Motion carried unanimously.

Senator Close arrived.

AB 226

Enlarges free distribution of advance sheets of session laws.

After the suggestion was made to include public defenders and city attorneys,

Senator Wilson moved "AMEND AND DO PASS" Senator Gibson seconded Motion carried unanimously.

AB 271 Creates separate fiscal analysis division of Legislative Counsel Bureau.

Ron Sparks noted that this bill does not add to, nor create any additional duties or responsibilities currently practiced. He also stated that there would be no additional costs involved in creation of the Division, and recommended passage of AB 271.

Art Palmer agreed with Mr. Sparks, and stated that the bill merely follows the way the Fiscal Division has always been operating.

John Dolan explained that staff, etc., could not be expanded without the approval of the Legislative Commission; and the subsequent appropriations.

Senator Gibson moved "DO PASS" Senator Gojack seconded Motion carried unanimously.

Chairman Echols then asked the members to review an inventory of the bills referred to the Committee. (Please see EXHIBIT A)

After discussing <u>SR 13</u>, Senator Gibson noted that Andy Grose had researched all of the existing laws, and subsequently, <u>SR 13</u> is an entirely new approach; not used previously. The various aspects of an ethics law were studied, and it was decided to try and meet jointly with the Assembly Legislative Functions Committee. It was the hope of the Committee to enact ethics legislation this session.

There being no further business, Chairman Echols thanked the Committee and adjourned the meeting at 2:42 p.m.



## MARCH 15, 1977 INVENTORY OF BILLS REFERRED TO LEGISLATIVE FUNCTIONS

- SCR 5 Directs legislative commission to study feasibility of conducting performance audits.
- SCR 14 Directs legislative commission to study and make recommendations on subject of pupil achievement.
- SCR 19 Requests study of labor-management relations in private enterprise.
- SR 7 Amends Senate Standing Rule 118 to change procedures relating to resolutions.
- SR 13 Creates Senate committee on ethics.
- SB 299 Directs legislative commission to study funding of judges' retirement.
- SB 341 Alters qualifications, powers and duties of legislative auditor.



- ACR 6 Directs the legislative commission to study provisions relating to obscenity.
- AB 39 Provides for collection of information concerning district attorneys and public defenders.
