Senator William Hernstadt appeared before the Committee to ask for an opinion relative to a possible conflict of interest in voting on <u>SB 212</u>. He explained that his wife is currently employed by the State of New Jersey, and might, at some future time, do work for the State of Nevada. After discussion, the Committee agreed that they could not foresee any conflict.

Chairman Echols asked for testimony on <u>AJR 46</u>, <u>ACR 9</u> and <u>ACR 31</u>, items on the agenda for public testimony. There was none.

SCR 38 Feasibility of establishing old veterans' home.

Senator Schofield moved "BE ADOPTED" Senator Raggio seconded Motion carried unanimously.

<u>SCR 39</u> <u>Nevada Industrial Commission (duplicates a</u> request on assembly side).

Senator Gibson moved "HOLD" Senator Schofield seconded Motion carried unanimously.

SCR 42 Health insurance coverage for treatment of alcoholism and drug addiction.

Senator Gibson moved "INDEFINITELY POSTPONE" Senator Schofield seconded Motion carried unanimously.

AJR 46 Proposes to amend Nevada Constitution to permit payment of legislators for 100 days of session.

Senator Raggio moved "INDEFINITELY POSTPONE" Senator Gojack seconded Motion carried, with Senator Schofield voting "NO".

ACR 31 Allows each house to choose its method of selecting alternate members of Legislative Commission.
