AB 195: Mr. FitzPatrick moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Bennett second the motion and the motion carried with Mr. Bremner and Mr. Weise voting against the motion and Mr. Sena not being present to vote.

AB 525: Mr. FitzPatrick moved to INDEFINITELY POSTPONE the bill, Mr. Bennett seconded the motion and it carried with Mr. Bremner and Mr. Weise voting against the motion and Mr. Sena not being present to vote.

<u>AB 202</u>: Mr. FitzPatrick moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Tanner seconded the motion and it carried with Mr. Bremner voting against the motion and Mr. Sena not being present to vote.

<u>AB 339</u>: Chairman Jeffrey pointed out that this bill is a companion bill to <u>SB 10</u> which has cleared the other house with amendments, therefore, Mr. Tanner moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. FitzPatrick seconded the motion and it carried unanimously with Mr. Sena not being present to vote.

AB 390: Mr. Horn moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Rusk seconded the motion and it carried unanimously. (Mr. Sena being present.)

<u>AB 420:</u> Mr. Tanner gave a brief report on this bill and it was <u>held</u> until the next regular meeting for further action.

<u>AB 455:</u> Mr. Rusk moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Sena seconded the motion and it carried with Mr. Chaney and Mr. Fitz Patrick voting against the motion.

<u>AB 509</u>: Mr. Tanner moved to INDEFINITELY POSTPONE the bill, Mr. Chaney seconded the motion; the motion was defeated and Mr. Horn moved to <u>DO PASS</u> the bill, Mr. Weise seconded the motion and it carried with Mr. Chaney voting against the motion.

<u>AB 464</u>: Chairman Jeffrey presented the amendments which had been drafted to the committee for their approval. Mr. Rusk moved for <u>adoption of the amendment</u> as presented, Mr. Sena seconded the motion and it carried with Mr. Horn voting against the motion.

<u>AB 510</u>: Chairman Jeffrey stated that he felt the committee should amend this bill to allow for a two year extension of the qualifying period and gutting the balance of the bill's provisions. Mr. Rusk moved to <u>AMEND AND DO PASS</u> the bill, Mr. Weise seconded the motion and it carried with Mr. FitzPatrick and Mr. Horn voting against the motion.

AB 522: Mr. Tanner moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Weise seconded the motion and it carried with Mr. Sena, Mr. Horn, Mr. FitzPatrick and Mr. Chaney voting against the motion.

AB 582: Mr. Rusk moved to <u>INDEFINITELY POSTPONE</u> the bill, Mr. Weise seconded the motion and it carried with Mr. Bremner and Mr. FitzPatrick abstaining.

<u>AB 597</u>: Mr. Tanner stated that he would report on this bill on the next regular meeting day and the bill was <u>held</u> for further action.

<u>AB 617</u>: There was discussion on this bill and its provisions. It was finally agreed that there would be added to the bill an amendment which had been submitted by Mr. Wadhams which would add another section and there would be a further amendment which would provide for higher levels of Uninsured Motorists coverage. Mr. Rusk moved to <u>AMEND AND DO PASS</u> the bill, Mr. Weise second the motion and it carried with Mr. Horn voting against the motion.

<u>AB 622</u>: Mr. Sena moved to <u>DO PASS</u> the bill, Mr. Bennett seconded the motion and it carried with Mr. Chaney voting against the motion.

AB 691: Mr. Wise moved to INDEFINITELY POSTPONE the bill, Mr. Chaney seconded the motion and it carried with Mr. Horn voting against the motion and Mr. Jeffrey not voting.

<u>AB 692</u>: After a brief discussion it was decided that this bill be <u>held</u> until the next regular meeting day.

AB 710: Several amendments were discussed relative to this bill and it was decided that the bill would be <u>held</u> until the next regular meeting day.

<u>AB 516</u>: Proposed amendment were presented which had been agreed upon by the Washoe County District Attorney's Office and the Electrical Dealers Association and they were approved by the committee. It was also decided to add an amendment which would

exclude warranty work which was done at no charge to the owner of the repaired item from the provisions of the bill. Mr. Rusk moved to <u>AMEND AND DO PASS</u> the bill, Mr. Weise seconded the motion and it carried with Mr. Tanner voting against the motion.

SB 10: Mr. Bremner moved to RE-REFER the bill to Ways & Means, the motion was seconded by Mr. FitzPatrick; however the motion failed and action was held to the next regular meeting day.

<u>SB 172</u>: Mr. Rusk stated that he had met with both the Opticians Board and the Board of Optometry relative to their differences of opionion on this bill and it was agreed that their differences could be resolved by changes within the regulations of the State Board of Dispensing Opticians and that both factions would then support the bill, if it were passed as printed. Mr. Rusk moved to <u>DO PASS</u> the bill, Mr. Horn seconded the motion and it carried unanimously.

<u>SB 232</u>: Mr. Horn moved to <u>DO PASS</u> the bill, Mr. Bennett seconded the motion and it carried unanimously.

<u>SB 233</u>: After a brief discussion it was decided that this bill would be held until the next regular meeting day.

There being no further business to come before the committee at this time, the meeting was adjourned due to prior commitments of the committee members. Time of adjournment, 6:15 p.m.
