Chairman Horn called the meeting to order at 3:10 p.m. He explained to the guests that the committee had met with representatives of the southern part of the state one week ago and had discussed some tentative language as a starting point on AB 147.

AB 147: Changes certain provisions of law regarding place and notice of precinct meetings and bans appointment of delegates to certain party conventions.

Mr. Horn said he would read the bill with this new language, which is attached to these minutes as Exhibit 1, and note any objections which would be discussed later.

Bob Sullivan, Carson River Basin Council of Governments, said that they liked the new language, that their only concern had been the requirement of notification of every voter by the registrar which has been deleted from the bill. He said they appreciated the changes made by the committee in either Exhibit 1 or Exhibit 2 also attached to these minutes.

Arthur Cruickshank, a volunteer lobbyist for Common Cause, said that their concerns were openness of meetings and publication of meetings which he felt were covered and stated that they were very much in favor of the bill.

Pete Kelley, representing the Nevada State Press Association, stated that they would like to retain the original language in lines 15-20 and Mr. Horn pointed out this has already been proposed and the committee were in agreement. Mr. Kelley said that with this change they were in favor of the bill.

Mr. Horn explained that this language was just a working format and not in bill drafting language. He then reread lines 9-14 on Exhibit 1.

Ken Haller, Washoe County Democratic Party, said that they objected to meeting in homes because the only problems Washoe

County has had have evolved from meetings in private homes. He said that their preference was public schools.

Mr. Bedrosian questioned Mr. Haller regarding the practice in Washoe County of having several precincts meeting in one room which Mr. Waterman had said was illegal. Mr. Haller said that they had changed the law to read voting districts in 1970.

Mr. Malone asked if all the voting districts have public buildings to which Mr. Haller replied that all districts have public schools.

Assemblyman Getto suggested narrowing the places down with four alternatives: a.) If at all possible, in the regular polling place for the precinct; if this is not feasible, b.) In any public building within the precinct; if no suitable public building is available, then the precinct meeting may be held c.) In any private building within the precinct; d.) If no suitable public or private building is available within the precinct, then in any public building within the ward or voting district, if any, in which such precinct is located.

Mr. Bedrosian asked Mr. Haller how he felt about restricting meetings initially to polling places and Mr. Haller replied he objected because there were oftentimes better places available. He added that their last precinct meetings had been held in polling places which were schools but that there were some polling places that would be unacceptable such as a synagogue, country club or VFW hall.

Jac Shaw from Douglas County stated that he had been a county chairman three times, state chairman two times, and that the original intent of precinct meetings was a neighborhood feeling. He explained that in his small county the most successful precinct meetings had been held in homes and suggested that possibly this bill should be addressed to only large population areas such as Washoe and Clark Counties. He added that although he felt it was a wrong direction for the state to interfere in politics, this bill would not preclude meetings in private homes with the new language.

Mr. Horn said that the next objection was Mr. Haller's to the new language beginning on line 44.

Mr. Haller objected to the words in the fifth line which say "until such an election is held" because he said he knew of no way an election could be held after the last precinct meeting. He said that the idea of having a meeting outside of a regularly scheduled meeting was abhorrent, unworkable, and would only cause problems. He added that in Washoe County they have solved this problem by holding a credentials meeting twenty-four hours before the convention at the convention site at which time all credential challenges, etc., are taken care of.

Mr. Haller's next objection was to the county central committee filling vacancies because he said it was impossible to convene 300 members of the central committee within the time frame. He felt that the party rules should be followed which allow the credentials committee or possibly the executive committee to fill vacancies.

Mr. Horn asked Mr. Haller if he had a strong objection to leaving the wording as it is and he answered no.

Mr. Shaw stated that he agreed with Mr. Haller that the words "until such an election is held in that precinct" should be deleted because he felt these words left a loophole for appointing delegates.

Mr. Horn stated that in his research there were three basic areas which must be defined: 1) credential challenges, 2) minority reports and 3) vacancies and the filling of vacancies. He said that the committee must be careful not to prohibit the filling of vacancies or the other two points.

Mr. Shaw stated that if a precinct meeting was not held, you would not be filling a vacancy.

Mr. Bedrosian asked Mr. Shaw if the republican party fractionalized votes and Mr. Shaw replied that this was a county option.

Mr. Horn asked how many would prefer Exhibit 1 over Exhibit 2 and the majority of the guests preferred Exhibit 1.

Mr. Horn referred to the new section four and said that Mr. Haller had an objection.

Mr. Haller stated that it was a minor objection but that he felt "or conference" should be added at the end because the democratic party will have a conference at mid-term.

Mr. Horn asked if this would cause anyone a problem and Mr. Shaw stated that it did not cause a problem but that he did not feel it was relevant because the bill only addresses conventions.

Mr. Haller presented the committee with a letter indicating eight points of concern of the Democratic Party of Washoe County, a press release dated February 23, 1978, a preamble to the delegate selection rules and rules governing precinct meetings, a list of polling places in Washoe County, a copy of a letter regarding insurance premiums, and two letters concerning procurement of schools for precinct meetings that are attached to these minutes as Exhibits A through G.

Mr. Horn asked Mr. Haller if he would send a letter explaining how Washoe County is able to hold precinct meetings in schools because of the problems encountered with the school districts in Clark County.

Mr. Haller stated that he felt AB 147 only muddied the water and came in for the wrong reason.


Mrs. Hayes asked Mr. Haller to please explain his statement. Mr. Haller stated that he thought the bill came in because some people were excluded from precinct meetings and some other people were excluded from county meetings. He added that he knew some people were excluded from the state meeting. He said that it was not the small counties because they were over attended. He stated that he felt they were approaching something from the wrong direction just because of something that happened in Clark County.

Mrs. Hayes suggested that it should read "qualified members of the party residing in the precinct" rather than "qualified members of the party only from the precinct".

The committee then discussed the suggested changes and unanimously decided upon Exhibit 3 to be presented to the bill drafter for amendments. Exhibit 3 is attached to these minutes.

Mr. Horn adjourned the meeting at 4:10 p.m.

Reference: AB 147 - changing place and notice of precinct meetings and bans
appointment of delegates to county conventions

1. The Democratic Party has been moving toward more and more open participation in Party affairs, and has ensured this by developing written National and State Charters that guarantee affirmative action and democratic processes. Often Nevada statutes stand in the way of the ideal, so the process has developed of working around the unworkable parts of NRS, and of interpreting the inconsistencies, while working for legislative remedies. The US Supreme Court has affirmed this practice in Singer vs Daley and Wigotta vs Cousins.
2. Precinct meetings are part of a sequential calendar which is very complex, especially during presidential election years. In the past twelve years in Washoe County there have been frequent last minute adjustments to plans.
3. Precincts and registered voters change. In Washoe we will register a voter at the precinct meeting in order that he or she may participate. We have even registered those who were not yet eligible in the case of those who would be 18 by the time of the next election.
4. Washoe has met in schools since 1970, although at first some meetings were held in places like the Verdi Community Hall and the Reno Sparks Indian Colony. In 1978 all meetings were held in the high schools and one Middle School. Precincts were grouped together in Assembly districts except for Gerlach/Empire/Vya. That totals 8 meeting places for 251 precincts.
5. There were 59 polling places in Washoe County at the 1978 general election. Some of these are private property. (See exhibit #3, attached)
6. Insurance is becoming prohibitive. (See exhibit #4, attached)
7. What provision will be made for the mailing precincts? Washoe had 51 in 1978.
8. The county conventions will continue to have the power to seat or not seat delegates, and the delegates will no doubt continue the tradition of seating those who missed precinct meetings for good cause such as illness or absence due to duties in Washington, D.C.. We shall continue to seat elected public officials such as Assemblymen and Senators,

RENO, NEVADA--"More than 500 Washoe County democrats will attend the biennial mass precinct meetings on the evening of February 28," said Ken Haller, Washoe County democratic chairman.

"This year we are making a change in the meetings, we will group them according to assembly district number," he said.

The democratic elected officials from the assembly districts will coordinate the mass precinct meetings. They will instruct those attending to elect delegates for the county convention and to propose planks for the county platform.

The delegates will later adopt the platform planks at the Washoe County Democratic Convention, Mar. 31-Apr. 1.

"We believe that the platform should be written by the grass roots democrats, and not dictated from a small clique of leaders," Haller said. "The precinct meetings provide a forum for all democrats to express their ideas and needs to the party."

All interested democrats may attend their precinct meetings, beginning at 8PM, Tuesday. There is no registration charge for attending the meetings.

"If you are interested in the democratic party and are not yet registered to vote, you may do so that evening. Deputy registrars will be available at the meetings," he said. "This is most important for young people who will be 18 before September 12, 1978, if they want to vote in the gubernatorial election."

"I'd like to like to make special mention of the democrats in Incline. This is the first time that they will conduct their own meeting. Bill Couey will coordinate activities at Incline High School," Haller commented.

Democrats in Gerlach-Empire will meet at Gerlach High School with Judge Ray Paschall.

"There is a tremendous amount of work that goes into organizing precinct meetings. The Washoe County Democratic Party owes a big thanks to those wonderful volunteers who are running the whole show and to our elected officials who donate their time. No one is being paid; democrats know how to volunteer," Haller said.

PREAMBLE

The purpose of the Delegate Selection Rules of the Democratic Party of Nevada is to allow a fair representation at all levels of the delegate selection process to candidates for the office of President of the United States.

The Democratic National Committee, through adoption of the Report of the Delegate Selection Commission, has declared that the prime focus of the Rules of the Democratic Party of Nevada should be to comply with those rules as stated in the report. Significant deviation is discouraged.

The Supreme Court of the United States, in the decision of *Singer vs. Dalay*, which concerned the challenge of the Illinois delegation to the 1972 National Convention, has stated that the process of nomination of candidates to the Presidency transcends state and local law and affirms the right of the National Party in convention to establish its own rules for delegate selection. The Supreme Court of the United States, in the decision of *Wiggotta vs. Cousins*, has stated that party rules have priority to state statute.

Therefore, it is resolved that it is the intention of the Democratic Party of Nevada to comply with the Delegate Selection Rules of the Democratic National Committee as are in effect for the 1976 Convention.

The Nevada Election Statutes provide for a Presidential Preference Primary Election to be held the fourth Tuesday in May, 1976 (May 25).

Special difficulties arise in conforming with National Delegate Selection Rules regarding candidate preference, in that the delegate selection process is culminated at least two weeks prior to the State Presidential Preference Primary. Therefore, care has been taken to assure that the delegates selected at the State Convention will pledge to represent the preference of voters of Nevada as expressed in the Primary, for two ballots; and will also be identified clearly as to their personal preference of presidential candidates.

First Step/Level of Delegate Selection Process

The first step of the selection of National Convention delegates and alternates will occur at the precinct meetings.

Participation At All Levels

All persons wishing to be delegates or alternates to the national convention shall have participated at every level of the delegate selection process.

Secret Ballot

All voting shall be by secret ballot. All tie votes affecting the outcome of an election shall be determined by lot immediately following the election.

Plurality

In all elections a plurality shall be sufficient to elect.

Election Agenda Item

In all elections, time and place shall be fixed on the agenda and shall not be moved.

Number of Ballots

In all elections, the number of official ballots cast shall not exceed the number of official ballots issued, or said election shall be declared null and void.

Notice

No less than 30 days public notice shall be announced before any precinct meeting or convention.

Robert's Rules of Order

Robert's Rules of Order, most recently revised, and the national party rules shall be the final arbiter of procedure at all meetings, caucuses and conventions.

PRECINCT MEETINGS

In General

In order to assure full participation in affairs of the Democratic Party in Nevada, persons wishing to become delegates to the national convention must attend and participate in all levels of the delegate selection process. The precinct meeting is the first step in the selection of delegates to the national convention and its prime purpose is to elect delegates to the county conventions.

Number of Delegates

The number of delegates from each voting precinct in each county to the county convention for such county shall be in proportion to the number of registered Democrats residing in such precinct as of January first of the general election year, or new precinct formed after January 1, 1976.

Public Buildings

The meetings shall be held in public buildings where available, accessible to all party members, and large enough to accommodate all interested Democrats.

Time and Place

The precinct meetings shall be convened and organized promptly at the time and place appointed therefor. If access to the premises appointed for any such meeting is for any reason not available, any two persons entitled to vote at that meeting may convene the meeting at an accessible place immediately adjacent thereto.

Open Meetings

All precinct meetings shall be conducted openly and publicly and in such a manner that they are freely accessible to any registered Democrat who resides in the precinct and is desirous of attending the meeting. Any Democrat voter may participate in any matter considered during their attendance.

Democratic Registration

Democratic registration and residence within the particular precinct shall be required to establish voting privileges at any meeting.

Attendance Register

A register of attendance at the meeting showing name and address of the attendees shall be kept by the secretary of the meeting and shall be forwarded to the county central committee. There shall be three copies distributed accordingly: 1) precinct secretary, 2) county chairperson, 3) county convention nominating committee.

Notice/Call/Date of Precinct Meetings

- A. The central committee of the Democratic Party in each county shall cause a precinct meeting of the registered Democrats residing in each voting precinct entitled to delegates to the county convention.
- B. It shall be the duty of the county chairperson to issue a call to precinct meetings at least 30 days prior to the date of meeting.
- C. All precinct meetings shall be held on Tuesday, March 9, 1976.
- D. Notice for meetings will conform with the provisions of the Nevada Revised Statutes relating thereto, and the Affirmative Action Rules of the Democratic Party of the State of Nevada.
- E. Requirements of the Nevada Revised Statutes include: 1) Posting notice in a conspicuous place outside the building where the meeting is to be held at least 5 days prior to the date of such meeting. 2) The notice shall specify the date, time and place of the meeting, and the number of delegates to the county convention to be chosen at the meeting.
- F. Affirmative action rules include the requirement that the general and target media will be used to inform the voting public of this first step in the delegate selection process at least one month prior to the meeting date. (See adopted Affirmative Action Plan.)

Conduct and Business of the Precinct Meetings

- A. The meeting will be called to order by the temporary chairperson of the precinct meeting. The temporary chairperson of the meeting shall be the precinct captain or such other precinct voter designated by the county chairperson, or in their absence, one should be elected from among those in attendance. Those attending shall then nominate and elect a permanent chairperson and permanent secretary for the meeting.
- B. The process of nomination and election of delegates and alternates shall be subject to the general provisions of the delegate selection rules and will follow the order as set forth below. The precinct chairperson will poll the attendees to identify themselves as to presidential preference, uncommitted, or no preference status. The attendees shall register their status on the attendance roster, which will be forwarded to the County Chairperson. Any declaration made at the precinct level shall not be binding. Delegates and alternates shall be elected in descending order of votes received. There may be elected a number of alternates equal to the number of delegates elected in following order of business:
 1. Nomination of delegates to the county convention.
 2. Election of delegates to the county convention.
 3. Nomination of alternates to the county convention.
 4. Election of alternates to the county convention.
- C. The precinct meeting may nominate to the county convention, one person from its delegation to the county convention, to be recommended for election to the state convention.

- D. Precinct meeting attendees who have lost election or have not been appointed to fill vacancies, for delegate or alternate to the county conventions, may attend the county convention for the purpose of submitting their names to the nominating committees for the Democratic State Convention. These persons must register with the nominating committee and by this action will satisfy the requirement for participation at this level of the delegate selection process. They may have no further standing at the conventions.
- E. Results of all elections shall be certified to the preliminary credentials committee of the county conventions by the chairperson and secretary of the precinct meeting.
- F. If any precinct fails to elect delegates to the county convention, the county central committee then in office shall make every effort to fill the vacancies, preferably from qualified members of the Democratic Party from that precinct, and the secretary of the county central committee shall certify the same to the county convention. Priority, in filling vacancies shall be given to Democrats who attended their mass precinct meeting.
- G. Where disputes arise in the election of delegates to the county convention, challenges shall be lodged with the chairperson of the preliminary credentials committee of the county convention.
