Chairman Dini called the meeting to order at 8:00 A.M.

AB 358 - REMOVES AUTHORITY OF BOARD OF COUNTY COMMISSIONERS OF CERTAIN COUNTIES TO ABOLISH OFFICE OF CONSTABLE

SPEAKER PAUL MAY, Assemblyman

Mr. May stated the office of Constable was an old, time-honored, traditional office based on townships with no respect to either city or county geographic lines. He stated that in Clark County there are 10 different townships. He advised the Committee that Woody Cole had been Constable of Las Vegas Township for many years, had died suddenly of a heart attack and, shortly thereafter, the County Commissioners introduced an ordinance to abolish the office and to transfer it to the Metropolitan Police Dept. He stated he felt the feeling among residents of Clark County was that the office should be retained; it serves an important position in the County; and they evidenced their feelings by petitions and telephone calls to Mr. May indicating that fact.

LOU TABAT, Constable, North Las Vegas

Mr. Tabat stated that the Civil Division of the Sheriff's Dept. in Clark County lost a considerable amount of money last year and stood to lose triple the amount if they were to assume the duties of the Constable. Mr. Tabat



had distributed to the Committee copies of an analysis of the cost of Constable functions prepared by the County Manager, a copy of which is attached hereto and made a part hereof. Mr. Tabat further indicated that last year the Las Vegas Constable's office served 21,000 Court Orders with 7 staff members and the Sheriff's Civil Division served 12,122 Court Orders with 15 staff members. He stated if they were to assume the Constable's duties they would have to hire 6 additional men and cars. Mr. Tabat advised the Committee that every paper the Constable serves costs the citizens \$4.73 while the Sheriff's costs are \$25.97. stated it would take 3 additional secretaries, or more, a lot of paper work was involved, and when the Sheriff's Department serves papers there is a lack of incentive to do so promptly as it is a salaried position whereas the Constable serves it right away because the more he serves the more he makes - it was a commission fee basis. stated the Sheriff's office lacks the time and manpower to perform the duties as the Constable does.

Mr. Jeffrey asked Mr. Tabat what his thoughts were to an amendment putting the Constable on a salary and do away with the objection the County has that the Constable makes more money than they should and the money should come to the County General Fund instead. Mr. Tabat said he would not mind it provided the deputies stayed on commission basis.

RICHARD DRAKE, Private Citizen

Mr. Drake informed the Committee he ran for the office of Constable last year; he had gotten a petition of over 2,000 names which he offered into the record, the first page of which is attached hereto and made a part hereof, and he stated that the petition to retain the office is the voice of the people.

FRITZ CRISLER, Constable, Henderson Township

Mr. Crisler spoke in favor of retaining the office. He elaborated on the functions of the office and stated actually they were not even Clark County employees any longer and that was not a good situation. He outlined the personal out of pocket expenses such as insurance and everything that comes out of his office. He stated that Clark County does not subsidize them in any respect.

JOHN J. HART, Constable, Reno Township

Mr. Hart testified in favor of retaining the office. He stated the Constable's office was important in relieving the Sheriff of duties he couldn't get done otherwise. He pointed out his office gives the extra service of Saturdays, Sundays, after 5 o'clock, and holidays and that was probably true in Las Vegas. Mr. Hart stated he was covered by a salary, as well as fees, and covered by N.I.C.

ROCKY ANDERSON, Constable, Dayton Township

Mr. Anderson stated he believed the law passed was unconstitutional and the Constitution states a legislative office enjoys the same right as a constitutional office to be voted on by the people, and he didn't believe the County Commissioners should have the power to eliminate the office.

FRANK SCHENCK, Civil Deputy, Lyon County Sheriff's Office

Mr. Schenck had a letter from E.L. Kingsley, Sheriff of Lyon County, which he read into the record, a copy of which is <u>attached</u> hereto and made a part hereof. The letter stated that in Lyon County it was not feasible to have a Constable due to the fact that they had 4 Justice Courts and each one in a different township and that it had been proven that the less expensive way to go is for the Sheriff's Dept. to handle the civil work and do it in a business-like manner.

In response to questions from the Committee as to the functions of the office in the cow counties, Mr. Schenck's testimony was that in the cow counties it was actually a losing proposition.

ED MALONEY, Chairman, County Commission, Lyon County

Mr. Maloney testified in favor of abolishing the office and putting it in the Civil Division of the Sheriff's Office. He went on to elaborate and enumerate the equipment and facilities available in the Sheriff's office to accommodate the duties and functions. He also outlined the economics involved and stated it was more than his county could have afforded.

KEN HILL, Dayton Township

Mr. Hill commented on the research he had done that the Constable is an elective office and he's got to be maintained by the elective process. He stated the Legislature did not have the power to abolish the office. He stated the Legislature does have the power to set the fees and regulate the duties through the County Commissioners of the Constable's Office but they do not have jurisdiction over the elective process just as they do not have jurisdiction over the county offices or the state. He stated he felt this was where the danger lies.

Mr. Getto questioned Mr. Hill in regard to testimony that the abolishment of the office would save money and Mr. Hill said he felt it would cost more money.

BOB SULLIVAN, Carson River Basin County Govt.

Mr. Sullivan stated he had been asked to give an opinion for Douglas and Churchill County. He stated they already had a Sheriff in those areas and perhaps the process is not as quick but it is done efficiently and the problem is when you have to make cuts, cuts are unpopular, and so it is a question of economics. He said they were trying to hold the line.

Chairman Dini announced the testimony on the Bill was concluded.

AB 379 - PROVIDES FOR FIXING MEETING PLACE OF BOARD OF COUNTY COMMISSIONERS BY ORDINANCE

ASSEMBLYMAN JOHN VERGIELS

Mr. Vergiels stated the Bill allows the County Commission to meet outside the building on Stewart and allows them to meet around the county, at the Convention Center, Boulder City, and Henderson, and it would make the meetings more accessible to people in outlying areas.

Mr. Jeffrey stated he thought the Commissioners ought to be allowed to go out and meet the people they represent. Dr. Robinson stated he thought people in a particular township should have a right to some hearing before formal action be taken on something that applies to them. He said he would not like to see a meeting held in Bunkerville on something that might apply just to the Strip and then take action on it up in Bunkerville.

RUSS McDONALD, Nevada Assn. of Counties

Mr. McDonald stated there is a statute that says that the County Seat of Clark County is in the City of Las Vegas. He suggested that what could be said is that they meet at the County Seat or close by within 5 miles if there is an accommodating structure. Mr. McDonald suggested an amendment starting on line 13 and 14 of the Bill as prepared by the Clerk of the Board of County Commissioners, Washoe County, a copy of which is attached hereto and made a part hereof.

SAM MAMET, Management Analyst, Clark County

Mr. Mamet stated the basic concern of the Board has been whether, in fact, they have the authority to hold formal Boards of County Commission meetings in other places than Las Vegas. He stated the District Attorney reviewed the statute and advised they did not and that was the reason for the requested amendment. He stated the Commissioners desire to have meetings around the counties in the various unincorporated areas several times during the year.

A discussion then ensued between the Committee members, Russ McDonald, and Sam Mamet concerning the situation in general and how an ordinance is adopted.

Chairman Dini then announced that the testimony on AB 379 was concluded.

Chairman Dini then entertained a motion for a Bill Draft Request to retain the State Board of Landscape Architects for another six years; setting a quorum at meetings for three members; and the question of fees; Mr. Jeffrey so moved; seconded by Mr. Getto, and unanimously carried.

There being no further business to come before the meeting, the same was adjourned.

THE COST PER CASE SERVED TO THE TAXPAYER HAS SKYROCKETED OVER THIRTY PERCENT (TOTAL \$8.42) IN THE LAST THREE YEARS.

THIS IS A UNIQUE OPPORTUNITY TO RESTORE INCENTIVE AND INITIATIVE TO A GOVERNMENTAL FUNCTION.

RESTORING THE CONSTABLE POSITION WILL PROVIDE 24 HOUR SERVICE TO THE TAXPAYING CITIZENS OF THE LAS VEGAS AREA.

EFFECIENCY AND EFFECTIVENESS NOT BIGGNESS MUST BE THE GOAL OF THE COUNTY COMMISSION IN MAKING THEIR DECISION.

PLACING THE CONSTABLE UNDER THE CIVIL PROCESS BUREAU COULD DOUBLE THE BUDGET TO \$629.804 WITH FUTURE INCREASES YEARLY OF 10% EACH YEAR.

CIVIL PROCESS PRODUCTION COULD DOUBLE TO 24,244 CASES SERVED BUT THAT WOULD LEAVE 8,878 CASES UNSERVED USING CURRENT CLARK COUNTY BUDGET FIGURES.





ANALYSIS OF THE COST OF CONSTABLE FUNCTIONS

Per your request the attached report sets forth the costs to the County for Constable functions under two systems: 1) a separate Constable Office as existed under Woody Cole and 2) a system whereby Constable functions are placed under the Civil Bureau. Under the separate office system, the County experiences a loss of revenue in the amount of approximately \$58,000 annually. Under the system whereby the Civil Bureau assumes the functions of the Constable's office it is estimated that the County will realize a revenue gain of approximately \$31,000 annually, and a total turn around figure of gain for the County of approximately \$90,070.

CONSTABLE'S OFFICE 1978

Below are the figures for expenditures and fees collected by the Las Vegas Constable's Office under Woody Cole. This is representative of the way funds would be spent when a separate Constable's Office is maintained in the Las Vegas Township as opposed to being combined with the Civil Bureau.

FEES COLLECTED

It is currently estimated that in 1978 the Constable's Office for the Las Vegas Township collected a total of \$102,501 for fees, eviction notices and mileage. None of the fees were turned over to the County but were used solely for the compensation of the Constable and his deputies.

** Total cost to the County under the "Separate Constable Office" plan is \$58,853 for 1978. County receives no reimbursement for this cost.

CONSTABLE FUNCTION IN CIVIL BUREAU, 1979

Under the current system where the Office of Constable is abolished and the functions of the Office are transferred to the Civil Bureau, a cost savings to the County can be realized. The figures below represent the estimated expenditures and fees collected for the staff in the Civil Bureau which would be carrying out the Constable function for the Las Vegas Township. As can be ascertained, no position of Constable is funded since the Director of the Civil Bureau will supervise the entire staff serving civil process.

FEES COLLECTED

It is estimated that the fees to be collected for Constable function by the deputy sheriffs in the Civil Bureau for 1979 will be approximately \$125,000. All of these fees will be turned over to the County to be placed in the County General Fund.

** Total revenues to the County under the plan where the "Civil Bureau" assumes Constable functions should exceed expenditures by \$31,317 for 1979.

Considering that the County under the previous system had been spending \$58,853 annually, the total turn around figure of gain for the County will be \$90,070 under the Civil Bureau plan.

WE, THE UNDERSIGNED REGISTERED VOTERS OF CLARK COUNTY, MEVADA:

FEEL THAT THE OFFICE OF CONSTABLE OF THE LAS VEGAS TOWNSHIP SHOULD NOT BE ABOLISHED.

The current proposal to make the Sheriff of Clark County the ex-officio Constable would place an additional burden on the taxpayers of Clark County.

An appointment to the post, vacant due to the untimely death of Constable Woody Cole, should be made by the Clark County Commission at the earliest possible date.

I believe that Constables can be very beneficial in a Metropolitan area but for Lyon County it is not feasable due to the fact that we have four (4) Justice Courts and each one in a different township.

A Constable is elected in a township and his duties can only be used in that township whereas Lyon County now has a Civil Department and the Civil Deputy can serve papers for all Justice Courts and since we have had the Justice Courts alternate their court days, the Civil Deputy can also act as Court Bailiff if necessary.

It has been proven that the less expensive way to go is for the Sheriff's Department to handle the civil work and do it in a business like manner.
