Vice Chairman Stewart chaired the meeting and called the meeting to order at 8:12 a.m.

ASSEMBLY BILL 267

Provides additional penalty for certain crimes against blind and aged persons.

Mr. Coulter said this bill was introduced in behalf of senior citizens living in his Assembly district. He said that he had mixed emotions on the bill. He said this was taking a specific segment of society and saying that there should be special punishment administered when acts are committed against that segment. California, Connecticut, and Hawaii have laws along this line, and he said several others states have similar legislation pending.

Mr. Coulter said that one important item in this bill was that the penalty could only be administered if there was serious bodily harm to a victim, and he said the three states that were mentioned have the same provision. He said that the position of the National Council of Senior Citizens was to increase penalties where there was harm to any victim of a crime. He said he believed that this is presently a consideration by courts in administering punishments.

Mr. Campos said that in talking with the Attorney General's staff, it was felt that there could be a constitutional problem with the bill. He said he believed the concept was good. He noted that there are laws in force that recognize age differences, and those pertain to children.

Mr. Campos suggested to the Committee that Item 1.j. in Section 1 of the bill be omitted because this would be a crime taking place between consenting adults. In response to Mr. Brady's question, he agreed that "manslaughter" should perhaps be changed to "voluntary manslaughter."

Mr. Dunlap said that he would support this concept. He also suggested that one other area be considered, and that would be arson. He said he believed the age division would hold up constitutionally.

Mr. Malone asked about the inclusion of larceny in the list of crimes in the bill. Mr. Dunlap related a specific case where larceny was committed against a senior citizen, and he agreed that this could be included.

Senator Faiss stated his support for the bill, and he said he had been informed that the bill could stand constitutionally.

ASSEMBLY BILL 277

Changes certain fees of constables.

Mr. Mamet said this bill was generated by constables in Clark County. The bill would raise the fees for constables set forth in NRS 258.125 to make them uniform with fees set for the Sheriff in NRS 248.275. He said these fees were last changed in 1975.

Mr. Banner and Mr. Sena stated their understanding that Clark County was trying to get rid of the constable position. Mr. Mamet said that the Board of County Commissioners has the statutory authority to take this action, and he noted that the ordinance that would do this was to be considered by the Board for final action on February 20. He noted, too, that there has been legislation introduced to take this authority from the County Commissioners. He said that with the introduction of this legislation, there may be some reconsideration on the part of the County Commissioners.

Mr. Horn raised several questions about the operation of the constable position in Clark County and the funding of the position. Mr. Mamet noted that the constable operates on a fee basis, and it is a "pay as you go" setup.

Mr. Mamet said the request had been made earlier to set up a salary for constables and make them peace officers. Fees collected would go to the county. He said one reason for not moving in this direction was the consideration of early retirement for a person who would be in this position.

It was brought out that the constable in Clark County earned \$50,000 in 1978. Mr. Malone said that the constable gets half of the fees he collects, and he stated that this bill would be providing a 50% raise for the constable.

Mr. Mamet stated that there was only one constable in the State who was making this much money. He said there would be other constables in the State who would probably be benefited from this legislation.

Mr. Horn asked Mr. Mamet to check with the Clark County Commissioners to see if they would be opposed to a salary being established for the constable.

SENATE JOINT RESOLUTION 10 OF THE 59TH SESSION

Proposes constitutional amendment to establish staggered terms for district judges.

Judge Fondi stated his support of this legislation. He said that approval of the resolution would alleviate some rather serious problems being experienced in Clark and Washoe Counties with not being able to add judges when they are really warranted, rather waiting until the expiration of a term as the time new judges could be added.

Judge Torvinen said he generally supported this resolution. He said that there was some worry expressed by judges who might draw one of the short terms with the implementation of this resolution. He said some of the judges would be a year short of qualifying for retirement if they drew a short term. He said he was interested in the provision removing from the Constitution the prohibition against salary changes during a judge's term of office.

Mr. Robison spoke in support of the resolution saying that there could be more judges appointed every two years rather than the present six-year time period involved. He said that new judges are needed in Washoe County now, and the earliest time under the resolution that additional judges could be appointed would be 1982.

Mr. Dunlap said he would support the resolution for the reasons stated. He said that it is critical to have more judges because of problems being experienced in Washoe County.

SENATE BILL 17

Makes available garnishment in aid of execution of judgments in small claims court.

Mr. Midmore stated that he understood this bill to be one submitted by the legislative counsel. He said that in a previous session of the Legislature, there was a bill enacted that took away the power of garnishment from the Justice Courts. He said this made the decisions of this court regarding payment of debts almost useless in some cases. He said this bill would simply give that authority back to the Justice Courts.

The Committee was in recess at 8:50 a.m. and reconvened at 9:13 a.m.

ASSEMBLY BILL 251

Revises provisions on compensation to victims of crimes.

ASSEMBLY BILL 273

Revises law on compensation for victims of crimes.

Assemblyman Wagner, prime sponsor of A.B. 273, noted that a side-by-side analysis of these two bills had been done so that they could be compared easier. She said that the Committee could consider the good points of both bills and come up with a Committee bill. She said the thrust of both bills is to add to the definition of "victim of crime" to include not only the "Good Samaritan", but to also include the innocent victim of a crime.

Mrs. Wagner said that Subsection 2 of Section 2 of each of the bills defined the purpose of the bills.

Mrs. Wagner said there are 23 states that currently have laws such as those proposed in the two bills. She said she felt it was quite unfair to spend millions of dollars to incarcerate criminals and then forget the plight of the victims. She said she had a list of victims of criminal acts (Exhibit A) who took their case before the State Board of Examiners and the outcome of those claims. She noted that these individuals were only those who felt they had a claim under the Good Samaritan Act.

Mrs. Wagner said that an important difference in the two bills was the definition of crime. She noted that her bill had set monetary limits on the amounts that could be awarded through the State Board of Examiners. She said the reason for this limit was because of the opposition that was encountered for a similar bill in the Senate during the last legislative session.

Assemblyman Price, prime sponsor of A.B. 251, said he felt that society had some obligation to help those that are down and out. He said it did not seem unreasonable to him to try to give victims of crime some type of break. Noting that his bill would attempt to collect a fine from lawbreakers to be put into a fund to assist victims of crime, he said that 99% of the people that commit the crimes do not have the money or earning power to make the restitution that would be needed.

Mr. Malone asked why larceny was left out of these bills. Mrs. Wagner said that this was a judgment of the bill drafter.

Mr. Price noted that a representative from the Christian Science Church had asked that language be written that would take into account nonremedial care and treatment rendered in accordance with a religious method of healing.

Referring back to his previous statement regarding restitution, Mr. Price said that the restitution payment could be made a condition of a person's parole.

Mr. Robison said he would urge passage of a combination of the bills. He suggested that in fining convicted persons the Committee set a percentage amount of the fine to be collected for the victim fund, perhaps 10%. He said that especially those clients who hire private attorneys would be able to pay this type of fine if it were imposed.

Mr. Miller said that legislation of this type was sorely needed. He said that Clark County has a Victim Witness Unit which is an effective tool in assisting victims and witnesses. However, he said that the unit has been lacking in monetary assistance for victims of crime.

Mr. Miller said he thought the definition of crime should be as broad as possible, but he said the definition in A.B. 251 was too broad. He said he thought the general concept of A.B. 251 should be prevalent in the bill that is finally passed.

Mr. Miller said he did not think the fine of \$25 imposed for the victim fund was sufficient. He thought it would be permissible to make the fine a \$100 minimum. In A.B. 251, Section 11, Subsection 1, he suggested deletion of the words, "shall determine if a person was killed or injured."

Mr. Dunlap said that the judicial system presently places the entire emphasis on the rights of the defendants. He said that because of defendants' rights, a victim is frequently brought into court and treated as some sort of criminal. He agreed that the \$25 fine in A.B. 251 was totally inadequate. He said he thought it was important to divert some of the money that is going into the general funds of the counties into a victim fund.

Mr. Horn suggested that the fine address a minimum amount of \$250 with a maximum amount of \$1,000, as the court may determine. Mr. Dunlap said this would be much better than proposed in A.B. 251 because there are some people who could pay the \$25 without it making a dent in their pocket.

Mr. Campos said he would urge the Committee to pass a bill of this nature. He said the bill has not passed in the past because of fiscal problems. This caused him problems, he said, because of the amount of money spent in the criminal justice system. He said that there possibly should be some allowance in the fine for a person that makes restitution payments.

Mr. Barrett related a fiscal note on these bills of about \$200,000. He said that this was approved by the Board of Examiners as being a reasonable amount. He said that the fines proposed to be collected would assist in helping victims of crime, but he said it would not be sufficient to totally offset these costs.

Mr. Yasmer said that the money provided in the budget being considered this year for criminal offenders was in excess of \$45 million. He said his department had done the fiscal note for the bills, and the amount projected was \$307,000.

ASSEMBLY BILL 105

Increases fraction of sentence prisoner must serve before becoming eligible for parole.

ASSEMBLY BILL 198

Increases amount of time served before parole.

Mr. Miller said he had talked to Warden Wolff of the Department of Prisons, and the warden had indicated he could tell the Committee that he could support A.B. 105 but did have problems with A.B. 198. Mr. Miller stated also that the District Attorneys Association had problems with a three-year minimum sentence.

Mr. Miller said that there was a lack of information submitted to his office when individuals were paroled such as the amount of good time credits earned and time spent in county jails that applied to a sentence. He said the public should be able to know how much time a person actually spends in prison.

Mrs. Hayes said that there was an amendment that had been prepared for A.B. 198 changing the minimum sentence time from three years to two years.

Mr. Miller said that Warden Wolff would probably have the same objections to a minimum of two years as he had with the three-year minimum. Mr. Horn felt this would be a very small impact in relation to the fiscal note that was mentioned

by the warden. He said that the chairman of the Ways and Means Committee had indicated to him the bill would have a better chance for passage in that committee with the minimum time served being changed from three years to two years.

ASSEMBLY BILL 277

Mr. Malone moved to indefinitely postpone; Mrs. Hayes seconded the motion.

Mr. Horn asked if it might be possible to amend this bill so that constables would be on a fixed salary as opposed to collecting half of the fees for himself with the remainder going into the general funds of the county.

Vice Chairman Stewart said that such a change in the bill might be so extensive that it would be better to start again with a new bill.

The Committee approved the motion on the following vote:

ASSEMBLY BILL 267

Vice Chairman Stewart said there had been some suggested amendments to this bill. The amendments were discussed, and no action was taken on the bill.

ASSEMBLY BILL 198

Mrs. Hayes again noted the amendment that had been prepared for this bill changing the minimum amount of time that must be served from three years to two years.

Mr. Horn moved to Do Pass as Amended and Re-refer to Ways and Means; Mr. Malone seconded the motion. The Committee approved the motion on the following vote:

ASSEMBLY BILL 199

Prohibits probation for a second or subsequent conviction of any felony.

Mrs. Hayes said that an amendment had been prepared to say probation would not be allowed for a second or subsequent conviction of a felony "if committed within 5 years after the prior conviction."

Mr. Horn moved Do Pass as Amended; Mr. Polish seconded the motion. The Committee approved the motion on the following vote:

ASSEMBLY BILL 168

Prohibits discharge of firearm at structures and vehicles.

Mrs. Hayes said that proposed amendments had been submitted by Mr. Dunlap on this bill. The amendment listed various structures that would be covered by this bill.

After discussion of other portions of the amendment, Mr. Horn moved Do Pass as Amended and to strike the word "gross" from the amendment; Mr. Malone seconded the motion. The Committee unanimously approved the motion.

ASSEMBLY BILL 30

Changes certain procedures for defending actions against public officers and employees.

Mrs. Hayes said that there were extensive amendments to this bill. She requested that the bill be amended and referred back to the Committee for further consideration.

Mr. Horn moved to Amend; and Re-refer to Judiciary; Mrs. Hayes seconded the motion. The Committee unanimously approved the motion.

Vice Chairman Stewart declared the meeting adjourned at 10:52 a.m.
