Chairman Banner called the meeting to order at 3:04 p.m. He called for testimony on S.B. 350.

S.B. 350 - Provides penalty for failure of producer-promoter of entertainment production to obtain permit and post bond with labor commissioner.

Mark Tully Massagli, Nevada State AFL-CIO president, testified in favor of S.B. 350. He is also president of the Musicians Union in Las Vegas. He explained that the Legislature in 197 passed NRS 608.300 to 320, pertaining to licensing of independent producers and promoters. The problem has been that there is no way to enforce NRS 608 because there was no penalty for not complying with the law. The law was granted in such a way that people in bonafide business and the hotels would be absolved from having to comply with the law. He said anybody can come into the state, get in touch with an entertainment director, posts notices and ads. And when he is out of work this person just folds up and leaves. If a person goes to the labor commissioner saying there is an independent producer that is advertising in local papers for musicans, dancers, and have no firm commitment to pay for these people, the labor commissioner just walks away because there is no penalty involved. He said S.B. 350 would meet the need for protection if the penalty was He urged passage of S.B. 350.

Chairman Banner asked Mr. Massagli if he knew of any objections to the bill when it was heard in the Senate. Mr. Massagli replied he didn't know of any, that the Senate Committee passed it 19-0.
