Chairman Sena announced that A.B. 70 would be heard at a later date.

A.B. 462 - Limits requirement for police officers to make reports of motor vehicle accidents.

Mr. Barengo said he presented this bill as part of the law enforcement package and that he knew nothing further about it. No other proponents appeared on behalf of A.B. 462.

Mr. Ketzenburger and Mr. Waugh questioned the intent of the bill as it was their understanding it should raise the limit above \$250 on those accidents required to be reported and A.B. 462 does not appear to do that. After committee discussion with Mr. Ketzenburger and Mr. Waugh, it was generally agreed that the bill had no particular merit.

Mr. Dehl appeared in opposition to A.B. 462 as he is against the philosophy of not taking traffic accident reports regardless of the amount of damage. He was of the opinion that accident reports filed by the police are the only unbiased reports available to the individuals involved. Mr. Dehl felt <u>A.B. 462</u> would be detrimental to citizens.

Mr. Virgil Anderson, American Automobile Association, concurred with Mr. Dehl's remarks in opposition to A.B. 462.
