Chairman Sena called the meeting to order at 7 a.m. for the purpose of a work session.

<u>A.B. 662</u> - Requires all taxicabs to have pollution control systems, and requires minimum fees of applicants for certificates.

Mr. Avance discussed the minimum fee of \$200 requested under this bill for filing an application for a certificate of public convenience and necessity with the Taxicab Authority. In response to Mrs. Wagner's questions, Mr. Avance said the cost of holding a meeting for the 3-member board was \$120 and this will go to \$200 when the board is increased to 5 members. They are requesting that the applicant pay this amount and the balance of cost incurred will be billed to the applicant. Mr. Glover was informed that the Gaming Control Board follows the same procedure in their investigations.

Mr. Avance said that sending two members of his staff to New York for five days would cost \$1,510. While these costs would be billed to the applicant, the committee felt that some limit should be placed on the fees to be charged. Mr. Avance said only two applications have been processed out of state in the past year and four local applicants. Mr. Stewart felt the language should be changed to place a limit on the fees and Chairman Sena asked that Mr. Stewart work with Mr. Avance on suggested amendments to A.B. 662. Mr. FitzPatrick presented the amendments to A.B. 591 which had previously been passed on April 9, 1979.

A.B. 476 - Mr. Glover had obtained certain amendments to this bill and asked Mr. Bob Guinn to review them with the committee. During this review an error was discovered on Line 40, page 5, wherein Sec. 11 should read "NRS 706.501 is hereby repealed." Since other questions were raised, Chairman Sena appointed Mr. Glover and Mr. Stewart to work with Mr. Guinn in correcting the suggested amendments.
