Chairman Sena called the meeting to order for the purpose of a work session to make decisions on various bills which had previously been heard by the committee.

After committee discussions, the following action was taken:

COMMITTEE ACTION:

A.B. 79 - Mrs. Wagner moved that the committee concur with Senate amendment #341. Seconded by Mrs. Hayes and carried unanimously.

A.B. 70 - To be rescheduled for hearing.

A.B. 359 - Mr. FitzPatrick moved to Indefinitely Postpone. Seconded by Mrs. Hayes and carried. Mr. Glover and Chairman Sena voted no.

Request for bill introduction - Chairman Sena said that the committee had been requested to introduce a bill whereby a taxicab company can sublease taxis to an individual.

Mr. Glover reminded the committee of the difficulty the bill drafters were experiencing this late in the session in drafting all amendments and other requests. He expressed the opinion that it would be unfair to the taxpayers to have this bill

drafted when it was so unlikely it would come to hearing.

The committee concurred with Mr. Glover's opinion and agreed that such a bill should not be considered at this time.

- S.B. 30 - Chairman Sena said he was holding this bill until requested research had been completed.
- A.B. 71 - Mr. FitzPatrick moved Do Pass. Seconded by Mr. Polish and carried unanimously.
- A.B. 74 - To be held until A.B. 70 is heard.
- A.B. 81 - To be held until Mr. Heber P. Hardy, Chairman, Public Service Commission, is contacted.
- A.B. 453 - Mr. Glover moved to adopt amendment 477 to A.B. 453. Seconded by Mr. Polish and carried. Mrs. Hayes absent.

Mrs. Wagner moved Do Pass A.B. 453 as Amended and rerefer back to Transportation Committee. Seconded by Mr. Polish and carried. Mrs. Hayes absent.

- A.B. 68 - Chairman Sena to request an additional amendment to A.B. 68 and A.B. 78 to include "light express as defined by the Public Service Commission".

Mr. Glover moved the adoption of amendment #272 to A.B. 68. Seconded by Mrs. Wagner and carried.

No other action on A.B. 68 until additional amendment is received.

- A.B. 78 - Mr. Glover moved the adoption of amendment #271 to A.B. 78. Seconded by Mr. Polish and carried unanimously.

- A.B. 476 - To be held under amendment is received.

- A.B. 67 - Committee discussion on amendments #288 and #471. Mr. FitzPatrick moved that Lines 30 to 35 on Page 2 be deleted. Seconded by Mr. Polish. Mr. FitzPatrick moved to amend his motion to include that lines 10 and 11 on Page 2 also be deleted. Motion defeated.

Chairman Sena to request bill drafter to use specific language requested by committee in amendment #288.

A.B. 108 - Chairman Sena and Mr. FitzPatrick to obtain amendments proposed by Department of Motor Vehicles and present to committee.

A.B. 281 - To be discussed with A.B. 453 when amendments are received.
