The meeting was called to order on Friday, May 18, 1979, at 4:50 p.m. with Senator Richard Blakemore in the Chair.

The Chair announced that this meeting was being held as a work session only. The Chair also announced that S.B. 563, S.B. 564 and S.B. 565 would be considered for action at this point since they deal with much of the same subject matter.\*

S.B. 565 "Proposes various amendments to laws relating to pharmacists and pharmacies."

Mr. Fred Hillerby of the Nevada Hospital Association discussed the amendments to this bill. Mr. Hillerby asked why in the definition of the chart order the language was not added which said that the chart order was sufficient as a prescription only for the administration of drugs to an in-patient and for take home drugs at the time of discharge.

Senator Hernstadt said that when this was discussed, it was decided to let the doctor write the prescription, and that is why the chart order did not appear in the final bill.

Mr. Hillerby said that he also wanted to know why in S.B. 565 the determination was made to take away the physical separation of the in-patient and out-patient, which in many cases is one room, but the new language which required a license for both was still left in the bill.

Mr. Russ McDonald of Washoe County said that in Mr. Hillerby's absence it was decided that if they didn't "buy" the physical separation, they would confer to look at the fee schedule for licensing at a later date.

Senator Hernstadt stated that what was agreed to was that the physical separation was removed; that there would be two licenses, "A" and "B", for the same facility; and, only one fee would be charged.

Senator Don Ashworth said that they had also decided that there would be a physical division in the inventory, with different racks for the same medication. Mr. McDonald said that this was provided for in the amendment as shown in the First Reprint.

Senator Blakemore said that in regards to Page 6, Lines 9-12 of the Reprint on <u>S.B. 565</u>, the Committee had agreed to two licenses and one fee. Senators Young, Hernstadt, Don Ashworth and McCorkle all concurred with this remark.

Mr. McDonald and Mr. Hillerby agreed to sit down at this time and formulate an amendment to S.B. 565 which would outline the license and fee process.

S.B. 578 "Changes certain fees collected by department of commerce."

Senator McCorkle moved for Indefinite Postponement of <u>Senate Bill No. 578</u>.

Senator Young seconded the motion.

The motion carried. (Senators Close & Wilson - Absent)

### S.B. 270 (Cont.)

Mr. Lawrence McCracken, Employment Security Department, stated that <u>S.B. 270</u> was originally written to reflect 1977 Commerce & Labor Committee's desire. Mr. McCracken said that the first part of the bill is to reduce an individual's benefits by one-half if the employer has paid one-half. If the employer had paid 100%, the individual would have the entire amount of his benefits reduced, by the amount of his pension, restricted to the base-period employer.

> Senator Don Ashworth moved Do Pass on <u>Senate</u> Bill No. 270.

Senator Young seconded the motion.

#### Discussion:

Mr. N.C. "Tony" Anthonisen suggested that the language in <u>A.B. 242</u> be amended into <u>Senate Bill No. 270</u>, (See Exhibit "A".

Mr. McCracken said that there should be an amendment which would allow the State to impose whatever law is passed by the Federal Government, (Exhibit "B").

Senator Don Ashworth said that his motion was still "Do Pass".

The Committee concurred that they would amend <u>S.B. 270</u> to include the language in <u>Exhibit "B</u>" to cover the Federal law.

Senator Young moved amend and Do Pass of Senate Bill No. 270.

Senator McCorkle seconded the motion.

The motion carried.

ASSEMBLY BILL NO. 242 - COMMITTEE ON LABOR AND MANAGEMENT

February 1, 1979

Section 1. NRS 612.350 is hereby amended to read as follows:

612.350 1. Each eligible (individual) person who is unemployed in any week shall be paid with respect to (such) that week a benefit in an amount equal to his weekly benefit amount, less 75 percent of the remuneration payable to him with respect to (such) that week (.) and less the amount payable to him as a pension allowance, or social security benefit payable by or on behalf of a base period employer as defined by NRS 612.025, or the amount payable to him as temporary partial disability compensation or temporary total disability compensation from the Nevada Industrial Commission or authorized workers' compensation self-insurer.

2. (Such) The benefit, if not a multiple of \$1, (shall) must be computed to the next higher multiple of \$1.

EXHIBIT "B"

L.

FOR ANY WEEK WITH RESPECT TO WHICH AN INDIVIDUAL IS RECEIVING A GOVERNMENTAL OR OTHER PENSION AND CLAIMING UNEMPLOYMENT COMPENSATION, THE WEEKLY BENEFIT AMOUNT PAYABLE SHALL BE REDUCED BY THE ENTIRE PRORATED WEEKLY AMOUNT OF ANY GOVERNMENTAL OR OTHER PENSION, RETIREMENT OR RETIRED PAY, ANNUITY, OR ANY OTHER SIMILAR PERIODIC PAYMENT WHICH IS BASED ON ANY PREVIOUS WORK OF SUCH INDIVIDUAL IF SUCH REDUCTION IS REQUIRED AS A CONDITION FOR FULL TAX CREDIT AGAINST THE TAX IMPOSED BY THE FEDERAL UNEMPLOYMENT TAX ACT.
