The meeting was called to order at 2:30 p.m. in Room 213. Vice Chairman Senator Richard E. Blakemore in the chair.

AB 843 Regulates practice of photogrammetry,

Reese Harper, representing the Nevada Association of Land Surveyors and Maurice E. Lafferty, representing the American Society of Photogrametry testified in support of <u>AB 843</u>. Mr. Harper explained that the Nevada Land Surveyors are in favor of the bill which would require photogramatrists to be licensed.

Mr. Lafferty explained that in California there had been licensure for photogrametry but recently the licensing has been eliminated.

Mr. Harper explained that when photogramatrists draw maps they are practicing land surveying, which must be licensed.

Vice Chairman Blakemore closed the public hearing on AB 843.

AB 597 Enlarges permissible real estate holdings by banks.

Joe Sevigny, Superintendent of Banks, Nevada, testified in support of <u>AB 597</u> which increases the limit for fixed assets. He explained that the fixed asset limitation is the amount of money that banks can invest in branches, their furniture, fixtures and computor equipment. He added that the present statute dates back past 1934 and is obsolete. He said that the present law is 60% of capital stock and permanent surplus. He stated that the Nevada bankers support the bill also. The bill would change the limitation to 60% of more accounts. He explained that California has eliminated their limitation entirely; they act on a safety and soundness principle which means that the superintendent of banks looks at the earnings of the bank and the cost of the fixed asset a makes a judgement based on that. Mr. Sevigny stated that Nevada is the 6th worst in the nation with regard to branching; there are about 5,100 people per branch as compared to 2,300 in South Dakota.

Vice Chairman Blakemore called a recess at 3:00 p.m. so that the Senators could attend the General File Session.

The meeting resumed at 6:00 p.m. with Chairman Wilson in the chair and Senator Young absent.

AB 781 Increases bond of cash deposit required of contractors.

John Madole, representing the Associated General Contractors, explained the bill to the Committee. He stated that it would raise the bonding on a contractor's license and would give the option to the contractor who has the license to post either treasury bonds or notes. He added that the bill would allow the contractors board, after 2 years, to relinquish the bond.

Tom Cooke, representing the State Contractors Board and John Brooke, representing the State Contractors Board testified in opposition to <u>AB 781</u>. Mr. Cooke explained that the amended bill is better than the original, however, after meeting with the contractors board today, his position is still in opposition.

Mr. Brooke answered Senator Ashworth that the highest bond the board has ever levied is \$20,000 in a case where the contractor had a poor track from the past. He added that the average bond is \$5,000. Mr. Brooke continued that this bill would be too hard on small contractors.

Chairman Wilson closed the public hearing on AB 781

<u>AB 510</u> Provides for registration as architects or residential designers of certain persons with prior business experience in drafting or design.

Discussion: Senator Blakemore stated that <u>AB 510</u> had been heard at a previous hearing when the Committee was a subcommittee of two. On May 18, 1979 the Committee had moved to Indefinitely Postpone the bill. It was decided that the Committee had not been sufficiently apprised of the bill's intent, therefore it was agreed to hear the bill again.

Senator Ashworth explained that the Committee had felt that 5 years was long enough for a person to be able to pass the test. Senator Close stated that the test is far too difficult, that one would have to be an architect to be able to pass it.

Bill Knobe, registered residential designer, reiterated his testimony of May 11, 1979. He explained that there are 2 designers on the State Board of Architects and 5 architects. He added that about 20 people have taken the test and 5 have passed it. He stated that if the bill passes 14 designers would be permanent residential designers.

Senator Ashworth observed that architects should not be able to dictate requirements for residential designers.

AJR 38 Favors merger of Pan American World Airways with National Airlines.

Senator Blakemore explained that Pan American is an international airline with no domestic routes; they are trying to show, by merging with National that they are interested with domestic routes as well.

AB 597 Enlarges permissible real estate holdings by banks.

AB 420 Makes various changes to law relating to cosmetology.

Senator Blakemore explained that this is basically a "housekeeping" bill The Committee decided to keep the 10th grade education requirement; delete lines 22 through 25 of page 5.

> Senator Blakemore moved that <u>AB 420</u> be passed out of Committee with an "Amend and Do Pass" recommendation.

Senator Ashworth abstained.

Motion carried with Senator Young absent.

<u>SB 568</u> Authorizes public service commission of Nevada to inspect records and property of affiliates of public utilities.

Senator Blakemore moved that <u>SB 568</u> be "Indefinitely Postponed".


