Four Corners Budget

Senator McCorkle gave a summary of all the money that was spent From the description of the programs given, Senator last biennium. McCorkle feels that \$533,000 of the money was used well; \$634,000 was unnecessary because it was either spent administering or in a function which could be better handled by a local community with their own money; and \$463,000 was used in areas which he considered questionable and not obviously worthwhile.

Senator Lamb asked Senator McCorkle what his recommendations were. He stated that they have a policy decision to make. Whether the Committee wants to keep the whole program and only efficiently use half of it, or should they cut back the monies. Senator Lamb added that the problem is that the money needs monitoring.

Senator McCorkle said the personnel behind the program is very questionable in his mind. He thinks those people should be replaced, but that is not the Committee's job. The person running the program is Carol Hawks; the Governor is supposed to be responsible for the money and she administers it.

Senator Wilson asked if this is a problem that Interim Finance can address. Senator Lamb stated someone is going to have to slow down and more credibility is needed as to where that money goes. These projects should be reviewed to see if they are feasible.

Senator Echols said that in addition to the report that Senator McCorkle presented, that amount of money can be doubled because the federal government is spending an equal amount in administering that program. Everyone of the projects goes through a laborious process before they are approved. Senator Echols stated he is not totally convinced of the administration of this program and the reliability of this program. There are some questions that should be answered. They should be given an opportunity to defend what has been done.

Predatory Animal Control

Senator Lamb asked for the advice of the Committee on the Predatory Animal Control budget. In view of what has happened, he wanted to know if they should be called back in to the Committee. Senator Lamb stated he has someone coming in from the Attorney General's office and perhaps that would be sufficient. Senator Wilson asked if he knew that the bottom line was. Senator Lamb said he does know that they picked up a check for \$35,000 in the last two weeks. Senator Wilson commented that they should be returned for a Committee hearing.

S.B. 278 - Requires the health division of the department of human resources to maintain certain records to aid in identification of dead bodies.

Sam D. Mamet, Management Analyst for Clark County, spoke for the county. He said this bill was composed by their office of planning coordinator. (See Attachment A.)

Dr. William L. Thompson, Chief, Bureau of Dental Health, testified. He stated they have no opposition to this bill.



Before your committee Tuesday morning is legislation proposed by our office of county coroner. The bill would require local law enforcement agencies to provide the state bureau of dentistry with dental charts for all persons missing over 10 days along with a missing persons report and it would be a requirement to inform the bureau when missing persons are located. The coroner's office would be responsible for supplying the state division of health with dental charts of unidentified dead bodies. In essence, therefore, the state health division would be charged with a new responsibility of maintaining these files. There would, of course, be a fiscal impact to the state which the fiscal note indicates to be less than \$1,000 to maintain a centralized record keeping system.

To the best of our knowledge, there has never been prior legislation on this issue in Nevada, however, California law mandates that this type of system be used by that state's bureau of dentistry.

We appreciate your favorable consideration of this request.

In 1977 the Legislature passed A.B. 400 (NRS 389.015), a bill governing proficiency examinations. In order to meet the uniform testing procedures prescribed by the bill, tests must be developed which match closely the components of the Nevada Elementary Course of Study, the document upon which instruction in arithmetic, reading, and writing is based in the State. Analysis of existing examinations has shown that there is no good match between actual instructional components and available tests. Accordingly, a ninth-grade test was developed over the past year, using federal funds, and will be administered in March and April, 1979. Since A.B. 400 did not contain any fiscal note, an additional sum of \$110,000 will be required to implement NRS 389.015. The appropration is needed for funding the following tasks and products:

Estimated Costs of Tests and Related Items for FY80 and FY81

FY80 - It is imperative that the development of twelfth-grade tests occur in fiscal 1979-1980. The reason for this is that if districts are to administer this test as early as the eleventh grade (and that seems the logical thing to do to give the student every chance to pass it for his diploma), the test will have to be ready for use by the fall of 1980. This gives the Department the fall of 1979 to develop the test, and the spring of 1980 to pilot the test.

At this point there is no way of knowing whether or not the Stanford Achievement Test, or any other standardized instrument, is suitable for measuring the instructional components in arithmetic, reading, and writing in grades three and six. Again, our intent is to convene statewide task forces and ad hoc committees to make that determination. The technical assistance noted in 1.2.1 would be for consultative services of test companies to determine what correlations exist between the instructional components in grades. three and six and available shelf instruments. In order to develop a good and useful bank of items for the ninth-grade test we will have to create new piloted items for that bank. In addition, we will have to begin the process of test equating, since the ninth-grade tests to be given in 1980 and subsequent years will have to relate very highly to those given in 1979. Otherwise, the critics would say that one test was harder than another and thus unfair.

In addition, Department staff, with the assistance of Educational Testing Service, designed ninth-grade writing tests which were also field tested in 1978. Sixty teachers were trained in the scoring of the writing tests and sixty more will be trained prior to the spring testing. These teachers will read and score a total of 26,000 writing samples for grade nine alone.

Many more items will need to be validated for grades 9 and 12. In analyses conducted in conjunction with the minimum competency high school diploma program it was found that in the arithmetic section, of the 35 subskills defined in the program, only four (4) were measured by using the appropriate level Stanford Achievement Test (TASK). Eleven (11) other nationally standardized tests were examined with similarly poor results. The best correlation with the arithmetic subskills was found in the Nevada Elementary Course of Study which listed 30 of 35 defined subskills. Thus the development of a test which measures the defined subskills is clearly indicated.

COUNTY OFFICERS AND EMPLOYEES

245.065

Salary deductions for county employees' service as volunteer firemen prohibited. All county employees shall be paid their salaries as fixed by law, ordinance or resolution without diminution on account of any time spent away from county employment while acting as volunteer firemen of any regular organized and recognized fire department in the protection of life or property during working hours or fractions thereof which should otherwise have been devoted to county employment.

(Added to NRS by 1969, 43; A 1971, 223)

245.060 Travel expenses.

1. Writen any county or township officer or any employee of the county shall be entitled to receive his necessary traveling expenses for the transaction of public business, such expenses shall include actual living expenses, but the amount allowed for traveling by private conveyance shall not exceed the amount charged by public conveyance. Where it appears to the satisfaction of the board of county commissioners that travel by private conveyance is more economical, or where it appears that, owing to train, airplane or bus schedules or for other reasons, travel by public conveyance is impractical, or in case a part of the route traveled is not covered by public conveyance, the board of county commissioners, in its discretion, is authorized to allow for traveling by private conveyance an amount not to exceed the maximum per-mile allowance for travel by private conveyance of state officers and employees specified in subsection 3 of NRS 281.160.

2. All claims for traveling expenses and subsistence allowances shall be approved by the board of county commissioners before payment.

245.065 Public hearings for dismissed employees.

1. When an employee of a county other than a department head, county manager or county administrator who has been employed by the county for 12 or more months is dismissed from employment he may request within 15 days of the date of dismissal a written statement specifically setting forth the reasons for such dismissal. Within 15 days of the date of such request he shall be furnished such a written statement. Within 30 days after receipt of such written statement, the dismissed employee may, in writing, request a public hearing before the board of county commissioners to determine the reasonableness of such action. The board of county commissioners shall grant the dismissed employee a public hearing within 15 days after receipt of the written request. At the public hearing, technical rules of evidence shall not apply.

Boards of county commissioners are authorized to enact ordinances

necessary to make effective the purposes of this section.

3. The provisions of this section do not apply in counties having a population of 100,000 or more, as determined by the last-preceding national census of the Bureau of the Census of the United States Department of Commerce.
