#### PUBLIC SERVICE COMMISSION - Page 610

Heber Hardy, Administrator, submitted a proposal to upgrade certain employees positions and increase certain category items (see Attachment A). He explained that they have great difficulty getting high level auditors and engineers.

Senator Lamb asked Mr. Barrett how these changes affect other auditors employed by the State. Mr. Barrett said he thinks the salaries of PSC auditors can go as high as PSC needs to attract people, without affecting other auditors in State employment. He said PSC auditors must testify in court; therefore the Budget Division feels they should be paid more than other auditors. He said the Person-Senator Wilson nel Division has not yet agreed to these levels. affirmed that Personnel has not agreed to these levels; and that is the reason for the unclassified positions request in the revised budget.

> Senator Wilson moved to approve the revised positions as unclassified positions, as presented by the Public Service Commission.

The Committee discussed salaries and qualifications of these positions with Mr. Barrett.

Senator Lamb said these increases will throw things out of balance. Senator Wilson said this plan has been approved by Personnel as one which will not throw things out of balance. Senator Wilson stressed the importance of these positions.

Senator McCorkle asked if the Chief Auditor is a CPA. Mr. Barrett said he did not think so.

Mr. Barrett said what is being requested is money to first hire people under the classified service. If they can't attract people at that salary level, allow them to go the unclassified salary level.

> Senator McCorkle moved to place the Chief Auditor's salary at \$32,000 if the salary is unclassified.

Senator McCorkle remarked that the Chief Auditor runs the entire office.

Senator Gibson questioned placing a classified and unclassified salary on each position; the position will be filled at whatever

the largest salary is.

Senator Gibson suggested that the salaries be set at the classified levels and have the Commission come to Interim Finance if the positions cannot be filled. He said he prefers this solution to having two different salary levels. He proposed that the Committee go with the Public Service Commission's classified salaries and let them come to Interim Finance if necessary.

Senators McCorkle and Wilson withdrew their previous motions.

Senator Wilson moved to approve the Public Service Commission's revised budget.

Seconded by Senator Gibson.

Senator Lamb voted no.

Motion carried.

Senator Wilson asked if a motion is needed on the unclassified pay bill. Senator Gibson said no; Mr. Sparks will be responsible for monitoring this situation.

Senator Wilson asked if this budget will be amended if bills related to Marlette Lake are passed. Senator Lamb said yes.

#### ELEMENTARY GUIDANCE AND COUNSELING - Page 177

Mr. Sparks said this budget relates to A.B. 370.

Senator Gibson asked what would happen to Driving Instruction. Sparks said it would completely be taken over by school districts. Mr. Sparks said the Department of Education would like to substitute this program for Drivers' Training.

Senator McCorkle spoke in favor of the counseling program. He said the schools are very much in favor of this program, and regard this money as seed money to start a comprehensive counseling program.

Senator Gibson said this is not Department of Education money. He said the budget should be eliminated if Drivers' Education is no longer needed. He said he is concerned about what will happen to Drivers' Education.

Senator McCorkle said he heard that schools would charge students for this training and would prefer to see the program run that way. Senator Gibson said if the money is taken out, small districts may not provide driver education.

> Senator Jacobsen moved to change this budget back to Driver Education.

Seconded by Senator Gibson.

Senators McCorkle and Wilson voted no.

Motion carried.

Senator Gibson moved to approve this budget.

Seconded by Senator Jacobsen.

Senator Wilson voted no.

Motion carried.

Senator Wilson asked if the action on this budget affects the Committee's action on AB 370. Senator Lamb said no; but he does not expect AB 370 to pass. Senator McCorkle said the PTA argued that it was an either/or decision; they wanted the counseling program instead of drivers' education.

#### UNIFIED COURT PROGRAM - Page 795

Mr. Sparks remarked that this program is contained in 3 separate pieces of legislation. He briefly reviewed this legislation.

Senator Gibson remarked that the case has not been made for this budget. He said until they have an organization that he has more confidence in fiscally, he is not for the State assuming any more financial responsibility. He said the State does not have the assurance of what its responsibility is at this time. He said the Committee needs to work with the Court to make sure their budget is in the proper form; approving the above budget is moving too fast.

Senator Gibson moved to not approve this budget.

Seconded by Senator Glaser.

Motion carried.

Senator Glaser commented that this is an area not being considered in the realignment of general fund monies to taxpayers and counties; it is a considerable amount of money.

Mr. Barrett remarked that it is in the Executive Budget, but is untouched; they did not review it.

Mr. Sparks said if this program is cut it will save about \$7,000,000.

#### Bill Introduction

Senator Lamb submitted two bill drafts for the Committee's approval:

1) appropriation to the Department of Energy to economize use of energy in state facilities.

Senator Gibson moved that this bill be introduced by the Senate Finance Committee.

Seconded by Senator Wilson.

Motion carried.

2) reorganization of Mental Hygiene and Mental Retardation.

Senator Gibson moved that this bill be introduced by the Senate Finance Committee and be referred back to the Finance Committee.

The Committee concurred with the exception of Senator Wilson.

#### BUILDING AND GROUNDS - Page 69

Mike Meizel, Administrator, Buildings and Grounds, testified on the use of prison labor in his Division. He suggested that he contract with the prison to have them do specific jobs. He said most money might be saved in Contract Services where he has to contract for certain jobs such as painting. Senator Jacobsen supported this concept. He said Mr. Meizel could identify the projects and the Warden could take the responsibility for getting the work done.

Senator Lamb suggested a letter of intent be written to this effect to both Mr. Meizel and Warden Wolff.

Mr. Meizel said he does not have a large crew in southern Nevada and could use prison crews there.

Senator McCorkle asked, if money can be saved by using prison labor, why Mr. Meizel is not presenting cuts in his budget. Mr. Meizel replied there are always things to do; they will be able to do more than they did before.

Mike Medema, Chief Administrator Officer for the Prison, said the prison would need an additional position plus a vehicle to supervise the prison work crews.

Senator Jacobsen asked if the additional 25 prisoners recently added to the honor camp that is associated with the Forestry budget could be used for this work. There are 2 Forestry Supervisors for the additional 25 prisoners. Mr. Medems said if there are people to do this work through the honor camp, then the prison would not need additional funding. Senator Jacobsen said his intent was to use crews already being utilized, not create new crews.

Senator McCorkle moved to remove 5 existing positions from Buildings and Grounds.

Seconded by Senator Echols.

Senators Jacobsen, Glaser, Lamb, Gibson and Wilson voted no.

Motion did not carry.

SUBJECT: Revised Public Service Commission Budget

Due to continuing staff recruitment problems and increasing demands upon the resources of the Public Service Commission, a revised budget recommendation for the coming biennium is now being submitted for consideration by the Legislature. The changed grade levels for classified positions would require detailed review by the Personnel Division and may be set lower than the grade levels listed on the attachment. Classified salary levels would be set within funding limits as outlined in the revised recommendations, however.

This office requests consideration by the Legislature of the introduction of a bill giving the Governor the option of filling Public Service Commission auditors as unclassified positions should it prove impossible to recruit qualified persons at salaries corresponding to classified levels set by the Personnel Division. The recommended titles and salary level under this unclassified option would be as follows:

Chief Auditor - \$33,207 Senior Auditor - \$28,808 Auditor - \$26,212

It is also recommended that the existing classified Sr. Management Analyst position be changed to an unclassified position with a salary of \$28,000 per year.

- (1) The mill assessment rate is presently set at two and one half (2½) mills this proposal would not require an increase in mill rate during the coming biennium.
- (2) The attached schedule of payroll adjustment is supported by the following narrative:

Changes to Chairman and Commissioners to relieve compaction problem associated with 95% rule.

Changes to Staff and Asst. Staff Counsel to bring salary ranges closer to that of Deputy Attorney General Staff.

Change the management analyst position from classified to unclassified.

Chief auditor increase from a grade 41 to a grade 43.

Present supervising auditor from a grade 38 to a grade 40.

Creation from one vacant auditor IV position to a supervising auditor grade 40.

Balance of existing audit staff be allowed to advance to grade 38 instead of present auditor IV - grade 36. This is in addition to the present salary increase at their present levels of 10% the first year and 5% the following year of the biennium.

(3) Auditors(3) desks-\$795.00; (3) chairs-\$519.00; (3) calculators with cases-\$750.00. Equipment plus 5% AC amounts to \$2,167.00 estimated.

Dear Ron:

In view of the action taken by the Senate Finance Committee yesterday, I am attaching a copy of Public Law 94-482 which stipulates that each State receiving vocational education funds (about two million in Nevada per year) and CETA dollars (an average of twenty-five million annually) shall have a SOICC.

The elimination of the SOICC could impact far more than the all-Federal grant we have requested <u>authorization</u> to utilize in Nevada.

We have not been in operation long enough to have a track record to stand on but we have begun to make progress toward the development and implementation of a Comprehensive Occupational Information System (OIS) within the State. The efforts of the SOICC will benefit planners in the public and private sector dealing with the labor force and economic conditions as well as the student or young adult looking at long-range career development alternatives.

The SOICC will <u>not</u> duplicate current activities in the labor market information area but will pull together supply components such as students graduating from vocational education and technical training programs, products of employment and occupational training programs—public and private—veterans and apprenticeship training programs as well as the currently unemployed—seeking work, individuals who comprise a part of the available and potential work force.

By coordinating all the supply and demand components into an OIS, State and local planners can be more responsive to the needs of the State's citizens as well as to the changes in the State's labor market demands.

# THE EDUCATIONAL AMENDMENTS OF 1976 (PL 94-482) (Relevant sections)

- Section 161 "(b) (1) There is hereby established a National Occupational Information Coordinating Committee which shall consist of the Commissioner, the Administrator, the Commissioner of Labor Statistics, and the Assistant Secretary for Employment and Training. This Committee, with funds available to it under section 103(a) (as such section will be in effect on October 1, 1978), shall—
  - "(A) in use of program data and employment data, improve coordination between and communication among administrators and planners of programs authorized by this Act and by the Comprehensive Employment and Training Act of 1973, employment security agency administrators, research personnel, and employment and training and administering agencies at the Federal, State and local levels;
  - "(B) develop and implement, by September 30, 1978, an occupational information system to meet the common occupational information needs of vocational education programs and employment and training programs at the national, State, and local levels, which system shall include data on occupational demand and supply based on uniform definitions, standardized estimating procedures, and standardized occupational classifications; and
  - "(C) assist State occupational information coordinating committees established pursuant to paragraph (2).
  - "(2) By September 30, 1978, each State receiving assistance under this Act and under the Comprehensive Employment and Training Act of 1973-shall establish a State occupational information committee composed of representatives of the State board, the State employment security agency, the State Manpower Services Council, and the agency administering the vocational rehabilitation program. This committee shall, with funds available to it from the National Coordinating Committee established pursuant to paragraph (1), implement an occupational information system in the State which will meet the common needs for the planning for, and the operation of, programs of the State board assisted under this Act and of the administering agencies under the Comprehensive Employment and Training Act of 1973.

SEC. 2. As used in this chapter, unless the context otherwise requires:

1. "Board of trustees" means the board of trustees of the Nevada state museum.

"Director" means the director of the Nevada state museum. 2.

SEC. 3. 1. The joint board of museums and history, consisting of seven members appointed by the governor, is hereby created.

2. The governor shall appoint as members of the joint board:
(a) Three persons who are members of the board of trustees of the Nevada state museum, one of whom must be familiar with the Lost City 10 museum:

3. The governor 3. The governor shall designate the chairman of the joint board from among its members.

Section 1. Chapter 228 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 and 3 of this act.

SEC. 2. The attorney general may charge all state agencies which are not supported from the state general fund for all services his office pro-

vides to those agencies.

SEC. 3. Except as he is required by section I of Senate Bill No. 171 to deposit certain money in a special fund, the attorney general shall deposit in the state general fund all money collected by him which is in excess of the amount authorized for expenditure by the legislature.

463.011 "Game" or "gambling game" means any banking or percentage game played with cards, dice or any mechanical device or machine for money, property, checks, credit or any representative of value, including, without limiting the generality of the foregoing, faro, monte, roulette, keno, bingo, fan-tan, twenty-one, blackjack, seven-and-a-half, big injun, klondike, craps, [stud poker, draw] poker, chuck-a-luck, Chinese chuck-a-luck (dai shu), wheel of fortune, chemin de fer, baccarat, pai gow, beat the banker, panguingui, [or] slot machine or any other game or device approved by the commission, but [shall] does not other game or device approved by the commission, but [shall] does not include social games played solely for drinks, or cigars or cigarettes served individually, games played in private homes or residences for prizes or games operated by charitable or educational organizations which are

approved by the board pursuant to the provisions of NRS 463.409.

SEC. 2. NRS 463.075 is hereby amended to read as follows:
