A.B. 848 - Establishes committee to study feasibility of establishing program for continued professional development of teachers and makes appropriation.

Ms. Joyce Woodhouse, NSEA, testified on behalf of the bill.

Senator Wilson moved Do Pass

Seconded by Senator Echols

Senator Gibson absent Senator McCorkle voted No

A.B. 85 - Adopts Uniform Disposition of Unclaimed Property Act, with modifications.

Senator Wilson moved not to concur with the Assembly's amendment so that a conference committee could meet and correct the error.

Seconded by Senator Gibson

Motion carried unanimously

Senators Glaser, Jacobsen and Echols were appointed to go on the committee.

S.B. 587 - Appropriates money for industrial development.

Before making an allocation of \$5 Million for Ely for construction the committee shall satisfy itself that the cost of the building will be recovered by the state through payments for its use during the expected life of the building.

Assemblyman John Polish commented that he hoped this legislation would be approved by the committee.

Senator Lamb read an amendment stating that the Interim Finance Committee may allocate money from this fund for construction of one or more projects consisting of land, buildings, and equipment suitable to house one or more industrial enterprises. Before making an allocation the committee shall satisfy itself that the cost of the land, building and equipment will be recovered by the State.

Mr. Mike Bourn, executive director of White Pine County Development Corporation, stated he has discussed this amendment with the Governor and several other people. He said in his experience in economic development the most valuable kind of tool you can have is ready financing available for land, buildings, and equipment. This gives the developers some advantages to offer people to make up for the remoteness of the location in Ely.

A.B. 137 - To provide for collective bargaining by State employees.

Mr. Bob Gagnier, executive director of SNEA, said this bill sets up the procedure that was agreed on by the administration last summer. At the end of the 1977 Legislature they met with the State Personnel Division and worked for approximately one year in preparing and perfecting a personnel advisory rule for negotiation. It was agreed to by both sides. It was endorsed by the Governor and by the governing body of SNEA at the annual convention. It was submitted by administrative procedures to the LCB at which time Mr. Frank Daykin said it couldn't legally be done. Thelaw did not permit the adoption of this regulation. That is the purpose of A.B. 137, to provide for this kind of negotiated agreement.

Mr. Jim Wittenberg, director of the State Personnel Department, stated he was not certain this bill is needed, but it is up to the legislature. Mr. Wi tenberg said the fiscal note is \$72,000 each year.

Mr. Roger Laird, Employee Relations Officer, State Personnel Department, said the administrative judge was set up in the regulation in the factfinding to review disputes and to look at issues and to issue recommendations of resolution. The factfinder does not have to be an administrative judge.
