A.B. 107 - Revises provisions relating to state assistance in constructing health facilities.

Upon motion by Mr. Mello, seconded by Mr. Bergevin action on this bill was deferred for further consideration at the discretion of the Chairman. Motion carried unanimously.

> S. B 102 - Raises upper age limit of children for foster homes.

Present to testify in support of this measure was Mrs. Gloria Handley, Chief of Program Services for the Welfare Division. She explained that currently the law defines a foster home as a home in which children up to the age of 16 years of age are cared for. This bill would revise that definition to provice licensing of a home caring for children up to the age of 18.

She feels there isn't any justification for not licensing a home in which a child is placed when he is 16 or 17 years of age and currently there is that 2-year period where an individual would not be covered in a housing care facility under some form of licensing.

This should not have a tremendous impact as most of the individuals involved are presently under the care of the State in one facility or another. This measure would not be adding any additional homes, but it would give them authority to inspect, approve and license the homes that are presently being used for that purpose. She informed the committee that presently there are 544 licensed foster homes in the State and as of February, they were providing foster care services on behalf of 612 children. average expenditures for each person is about \$250.00 per month in board, room and costs.

Mr. Mello asked what the advantages were to licensing these homes if they are presently being used for that purpose and was advised by Mrs. Handley that this bill would merely provide them the protection of licensing, that is through the investigation of the kind of home in which the children will be placed. phasized that it will not be bringing any additional children into the system, therefore, it should have no fiscal impact that isn't
