1. CHANGE THE COMPOSITION OF THE ADVISORY COUNCIL TO THE DEPARTMENT OF INDUSTRIAL RELATIONS (section 278, page 89).

Sec. 278 1. There is hereby created in the department an advisory council composed of seven members appointed by the governor.

2. The advisory council must be composed of three representatives of organized labor, three representatives of management, at least two of whom represent major employers, and one member of the public. The representatives of organized labor shall be selected by the governor for appointment from the individuals whose names are submitted to him by the Nevada State Branch of the American Federation of Labor and the Congress of Industrial Organizations. The representatives of management shall be selected by the governor for appointment from individuals whose names are submitted to him by employer associations.

- II. CHANGE LANGUAGE CONCERNING THE APPOINTMENT OF DIVISION HEADS (section 283, page 90).

Sec. 283. The director:

1. Shall appoint administrators of the divisions of the department, subject to the approval of the Governor, who are respectively designated as follows:

- III. CHANGE LANGUAGE CONCERNING THE COMPOSITION OF THE BOARD OF DIRECTORS OF THE STATE INDUSTRIAL INSURANCE SYSTEM (section 80, page 21).

Sec. 80 1. The system must be supervised by a board of directors which consists of seven members appointed by the governor.

2. Three members of the board must represent organized labor, three members must represent policyholders of the system, at least two of whom represent major policyholders, one member must represent the public. The representatives of organized labor shall be selected by the governor for appointment from the individuals whose names are submitted to him by the Nevada State Branch of the American Federation of Labor and the Congress of Industrial Organizations. The representatives of management shall be selected by the governor for appointment from individuals whose names are submitted to him by employer associations.

- IV. REMOVE LABOR COMMISSIONER'S OFFICE FROM REORGANIZATION.

Delete sections 1-70 and wherever else labor commissioner appears.

- V. REMOVE LANGUAGE WHEREBY THE BOARD OF DIRECTORS OF THE SYSTEM APPROVES APPOINTMENT OF ASSISTANT MANAGERS (sec. 83, page 21, line 50) after board insert "." and delete rest of sentence.

Sec. 83 The board shall:

1. Appoint the manager, who shall serve at the pleasure of the board.  
(, and approve the appointment of assistant managers.)

Amend section 90, page 23, between lines 11 and 12 by inserting a new subsection 3 to read as follows:

3. May appoint outside the provisions of Chapter 284 of NRS  
not to exceed five persons in management positions designated  
by the board that report directly to the manager or an assistant  
manager. Once designated these positions cannot be changed with-  
out the approval of the commission created by chapter 284 of NRS.
