Chairman Westall convened the meeting 3:10 P. M.

AB 153 - Makes various changes in provisions regarding interim finance committee.

Chairman Westall announced AB 153 was first referred to Ways and Means. It was a complicated situation to get the wording adjusted so that interim finance would be able to function.

Assemblyman Vergiels explained the need for the measure and circumstances that had brought about the need for the measure.

The committee discussed some of the controversial provisions of the measure. The major existing objection was that the committee could vote down a measure and in forty-five days it was automatically approved. Ways and Means Committee amended the bill.

Mr. Vergiels explained AB 153, first reprint would require a project actually be approved before it could become operative.

Chairman Westall presented an amendment that made technical corrections only to AB 153. EXHIBIT I

Mr. Kovacs moved to amend and Do Pass AB 153; Mr. Rhoads seconded the motion; motion carried unanimously.

AB 372 - Provides for selection of alternate members for interim finance committee.

Chairman Westall said there was an amendment to AB 372 to bring the measure into line with the Speakers original purpose when the measure was requested. EXHIBIT II.

Mr. Barengo, Speaker of the Assembly, in support of the legislation said there was a need for the amendment in order to allow persons to be appointed by him with a view toward giving everyone experience on the interim finance committee. The amendment would delete section 2 of AB 372 and add in its place the following wording:

"If any regular member of the committee informs the secretary that he will be unable to attend a particular meeting, the secretary shall notify the speaker of the assembly or the majority leader of the senate as the case may be, to appoint an alternate for that meeting from the same house and political party as the absent member."

Mr. Brady moved to amend and Do Pass AB 372; Mr. Rhoads seconded motion; motion carried unanimously.

SB 293 - Enlarges legislative grounds.

Chairman Westall said this measure had been heard on April 2, but no action taken. The measure would bring under the jurisdiction of the legislature the lot behind the legislative building now in grass and trees. She specified most of the trees would remain should the area sometime in the future be converted to a parking lot.

Mr. May moved to Do Pass SB 293; Mr. Kovacs seconded the motion. Motion carried. Mr. Stewart voted "no". All others voted "yes".

Mr. May requested the committee introduce a bill to provide security for the archives. Mr. Kovacs seconded; agreement unanimous.

The meeting adjourned at 3:25 P. M.
