Mr. Bergevin moved that the budget be closed, Governor recommends as amended, seconded by Mr. Horn. Mr. Robinson asked what was done about the specialized equipment and other furniture. Chairman Bremner stated that this is being taken care of by other legislation. Motion carried. Brady, Hayes and Hickey absent.

Motion carried, Hickey, Hayes, Brady and Vergiels were absent.
