Chairman Bremner reminded the committee that this is the bill which establishes a state park at Walker Lake. He said that Assemblyman Redelsperger had checked with the Mineral County Commissioners and they said they were not able to match the 25 percent as they do not have the funds in their park budget.

Mr. Vergiels said there was no reason the committee's action in amending and passing the bill should not stand since if the County could not make the match the state would not expend the money. The committee agreed to send A.B. 429 on to the Senate.

Assigns duties to state fire marshal division and S.B. 74 directs that special radio frequency be designated.

Senator Lawrence E. Jacobsen appeared in support of this bill. He referred to the interim subcommittee which he chaired which was to study and develop a statewide master plan for fire protection and control and told of its activities.

One of the subcommittee's prime recommendations, Senator Jacobsen said, was to take the training program away from the University of Nevada and transfer it to the Fire Marshal's office. He stressed the importance of all fire departments receiving the same training in order that they could assist each other.

Chairman Bremner questioned the \$33,900 for training. Mr. We said these funds are for grants and will go into the existing Mr. Welden This is matched with federal funds. Senator Jacobsen program. explained the distribution of the funds throughout the state and that the program is the incentive to get small fire departments started.

As a member of a volunteer fire department, Mr. Marvel pointed out the importance of the training program and the role rural fire departments played in the everyday life of a community.

The bailiff of the supreme court and bailiffs of the district courts, justices' courts and municipal courts; Sheriffs of counties and of metropolitan police departments and their deputies; Constables and their deputies when carrying out their official duties; Personnel of the Nevada highway patrol when exercising the police powers specified in NRS 481.150 and 481.180; The inspector or field agents of the motor carrier division of the department of motor vehicles when exercising the police powers specified in NRS 481.049; Members of and all inspectors employed by the public service commission of Nevada when exercising those enforcement powers conferred by chapters 702 to 706, inclusive, of NRS; Marshals and policemen of cities and towns; 8. Parole and probation officers; Special investigators employed by the office of any district attorney or the attorney general;
10. Arson investigators for fire departments specially designated by the appointing authority; Members of the University of Nevada System police department; 11. The state fire marshal and his assistant and deputies; The brand inspectors of the state department of agriculture, when exercising the enforcement powers conferred in chapter 565 of Arson investigators for the state forester firewarden specially designated by the appointing authority; The deputy director, superintendents, correctional officers and other employees of the department of prisons when carrying out any duties prescribed by the director of the department of prisons; 16. Division of state parks employees designated by the administrator of the division of state parks in the state department of conservation and natural resources when exercising police powers specified in NRS 407.065; Security officers employed by the board of trustees of 17. any school district; The executive, supervisory and investigative personnel of 18. the Nevada gaming commission and the state gaming control board when exercising the enforcement powers specified in NRS 463.140 or when investigating a violation of a provision of chapter 205 of NRS in the orm of a crime against the property of a gaming licensee; 19.
