SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE January 21, 1981

The Senate Committee on Commerce and Labor was called to order by Chairman Thomas R. C. Wilson at 2:06 p.m., Wednesday, January 21, 1981, in Room 213 of the Legislative Building, Carson City, Nevada. Exhibit A is the Meeting Agenda. Exhibit B is the Attendance Roster.

by Chairman Wilson as being suitable for being heard concurrently or in series. The Nevada Industrial Commission hearings were also recommended to be approached in the above manner.

Chairman Wilson responded to Senator Hernstadt's inquiry regarding the potential drought by suggesting that the committee address the water meter issue and its attendant problems later in the legislative period if it is warranted at that time.

Chief Deputy Research Director Donald Rhodes then presented a succinct outline of his availability on an individual basis as well as for research requests and bill summaries for the committee. Liaison assistance between the committee and various state agencies was also mentioned as being a potentially helpful stance.

Copies of the bill log were viewed by the senators and it was brought to their attention by the chairman that an updated copy would be available to each of them on a weekly basis upon request. See Exhibit D.

With no further business, Chairman Wilson adjourned the meeting at 2:30 p.m.

COMMITTEE RULES - SIXTY-FIRST SESSION

COMMITTEE ON COMMERCE AND LABOR

- 1. Four members constitute a quorum of the committee. A quorum is required to hear a bill, budget or resolution.
- 2. A majority of the committee is required to pass a bill, budget or resolution.
- 3. Five members of the committee are required to reconsider a bill, budget or resolution.
- 4. A majority is required for committee introduction of a bill. Committee introduction does not imply in any way a commitment on the part of any committee member to support the bill introduced.
- 5. No committee action on bills, budgets or resolutions is permitted during a hearing.
- 6. The secretary shall record the votes of all committee members.
- 7. A minority report can be filed with the Secretary of the Senate at the same time that the committee action is reported. It may be signed by any members disagreeing who were present when the vote was taken. The members who desire to submit a minority vote must so indicate in advance to the entire committee.
- 8. No smoking is permitted in the committee room while a hearing is in session.
- 9. Committee recesses shall be at the call of the chairman.
