MINUTES OF THE MEETING OF THE SENATE COMMITTEE ON FINANCE

SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE April 3, 1981

The Senate Committee on Finance was called to order by Vice Chairman James I. Gibson, at 8:00 a.m., Friday, April 3, 1981, in Room 231 of the Legislative Building, Carson City, Nevada. Exhibit A is the Meeting Agenda.

COMPREHENSIVE STATEWIDE PLANNING - FEDERAL (Pg. 10)

Mr. Sparks noted this budget did not expect to receive either of the two sources of funds, the 701 or the 302. He said, on the current list, both of those funds were expected to be eliminated. If they were, the money would not come in to be transferred to the other using budgets.

Senator McCorkle moved to approve the COMPREHENSIVE STATEWIDE PLAN-NING - FEDERAL budget as recommended by the Governor.

Senator Jacbosen seconded the motion.

The motion carried unanimously.

COMMISSION ON THE FUTURE OF NEVADA (Pg. 12)

Senator Jacobsen commented that he had served on this commission and all its work had been completed.

Senator Jacobsen moved to approve the COMMISSION ON THE FUTURE OF NEVADA budget as recommended by the Governor.

Senator McCorkle seconded the motion.

The motion carried unanimously.

GROUP INSURANCE COMMITTEE (Pg. 56)

Senator Jacobsen moved to approve the GROUP INSURANCE COMMITTEE budget as recommended by the Governor.

Senator McCorkle seconded the motion.

GOVERNOR'S OUT-OF-STATE TRAVEL (Pg. 57)

Senator McCorkle moved to approve the GOVERNOR'S OUT-OF-STATE TRAVEL budget as recommended by the Governor.

Senator Echols seconded the motion.

The motion carried unanimously.

STATE UNEMPLOYMENT COMPENSATION (Pg. 59)

Senator Gibson recommended setting this budget at \$350,000 for each year of the biennium.

Senator McCorkle moved to amend the STATE UNEMPLOYMENT COMPENSATION budget to \$350,000 for each year of the biennium.

Senator Jacobsen seconded the motion.

The motion carried unanimously.

Mr. Sparks indicated the assessment would possibly not be needed for next year as the \$380,000 would probably carry over.

MERIT AWARD BOARD (Pg. 60)

Senator Jacobsen moved to approve the MERIT AWARD BOARD budget as recommended by the Governor.

COOPERATIVE PERSONNEL SERVICES (Pg. 110)

Senator McCorkle, referring to the program statement for this budget, questioned why the State was getting into that area and not the local jurisdictions. Mr. Sparks said the local jurisdictions paid for the program but did not have the proper expertise to do the service.

Senator McCorkle moved to approve the COOPERATIVE PERSONNEL SERVICES budget as recommended by the Governor.

Senator Jacobsen seconded the motion.

The motion carried unanimously.

INTERGOVERNMENTAL PERSONNEL (Pg. 112)

Senator Gibson noted if money was not available, the program would be cancelled.

Senator Echols moved to approve the INTERGOVERNMENTAL PERSONNEL budget as recommended by the Governor.

Senator Jacobsen seconded the motion.

EQUAL EMPLOYMENT OPPORTUNITY COMMISSION (Pg. 154)

Mr. Sparks indicated this was the budget that requested augmentation of \$18,000 in HUD monies. He noted this was the Federal funding for the programs referred to the State by the Federal Government.

Senator McCorkle moved to amend the EQUAL EMPLOYMENT OPPORTUNITY COM-MISSION budget to add \$18,000 for the first fiscal year for receipt of a HUD and training grant.

Senator Jacobsen seconded the motion.

The motion carried unanimously.

EQUAL RIGHTS COMMISSION (Pg. 150)

Senator McCorkle moved to approve the EQUAL RIGHTS COMMISSION budget as recommended by the Governor.
