MINUTES OF THE MEETING OF THE SENATE COMMITTEE ON FINANCE

SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE May 25, 1981

The Senate Committee on Finance was called to order by Senator Floyd R. Lamb, Chairman, at 7:00 a.m., on Monday, May 25, 1981, in Room 231 of the Nevada State Legislature Building, Carson City, Nevada. Exhibit A is the Meeting Agenda. Exhibit B is the Attendance Roster.

The meeting of the Senate Finance Committee was called to order by Senator Floyd R. Lamb, Chairman, at 7:00 a.m.

ASSEMBLY BILL 671

Mr. Paul May, Assemblymen, distributed a handout to the Committee members and began his presentation by giving a brief history of fire protection systems in Nevada. Mr. May stated that there are two basic problems within the State Archives Building: (1) lack of fire protection and (2) lack of security.

Senator Glaser asked, considering the delicacy of the articles stored in the Archives Building, whether or not they would be using a sprinkling system.

Mr. May said that they are proposing to use helon gas where documents are stored and sprinkle the rest of the building. He said that the use of helon gas will prevent water damage to the documents.

Senator Jacobsen said that he had taken the opportunity to personally go to the Archives Building and review the problem, and he had asked for a recommendation from the Fire Marshal as to what he felt was needed in order to properly secure the building. He said that the recommendation was \$1,400 to tighten the fire protection system, which would include the installation of smoke protectors and the like. Senator Jacobsen stated that he would like to know that

this is going to be the permanent residence of the State Archives.

Senator Gibson asked Mr. May if he had a breakdown as to how much of the appropriation would be allocated to the fire protection system and how much to the security system.

Mr. May said that he did not have that kind ob reakdown but that \$55,000 has been allocated to the helon gas fire protection system.

Senator Glaser asked if there would be a possibility of allowing the biddger to be responsible for plan checkin and design in order to cut down costs.

Mr. May said he saw no reason why that couldn't be done.

ASSEMBLY BILL NO. 528

Mrs. Peggy Westall, Assemblyman, explained the bill to the committee, especially the financial impact of the bill. Mrs. Westall indicated that the only problem that really hampered a proper investigation of Personnel was the fact that this study was not done by the Legislature.

Senator Jacobsen asked why the price of this study is so high.

Senator Lamb asked if they proposed to have a ten-member panel.

Mrs. Westall said that the feeling of the Subcommittee was that they needed a large panel to do an in-depth study. She stated that the consensus is that the Legislators are tired of hassling with this problem every Session, and the best way to deal with the problem is to have an in-depth study of the situation.

Senator Lamb said that more could be accomplished with a much smaller panel. Senator Gibson said that in looking over the fiscal note, a very minor part is attributable to the cost of the panel; that the main expense category is for the hiring of consultants. He added that similar legislation was being proposed in the Government Affairs Committee.

Mr. Robert Gagnier, lobbyist for SNEA, simply endorsed the bill.

Senator Jacobsen inquired if the Personnel system in the State of Nevada is patterned after after particular state's personnel system

Mr. Jim Wittenberg, Director of State Personnel, stated that he believes the system in the State of Nevada is basically a good system.

Senator Jacobsen asked Mr. Wittenberg if he would like to address the claims that there is a great deal of antagonism between State employees and the State Personnel system.

Mr. Wittenberg replied that there is antagonism to some degree between all personnel and management no matter where this situation is found. He said that the posture of the management is very important in determining the employees' attitude toward management. He said that a negative or unresponsive attitude on the part of the management could result in antagonism between the two, Senate Committee on Finance May 25, 1981

Senator Jacobsen asked if Mr. Wittenberg feels that the proposed study will bring out some points that have not heretofore been uncovered.

Mr. Wittenberg stated that he feels the issue of performance-based pay should be addressed and whether or not it is necessary to have a statute which would mandate a collective bargaining system.

Senator Jacobsen asked Mr. Wittenberg to provide him with a copy of all the studies that have been done on this subject for the last five years.

Mrs. Westall stated that it is their intention to look at all aspects of the situation.

ASSEMBLY BILL NO. 573

This bill was presented by Mr. Merlin Anderson, Commissioner on the Post Secondary Commission on Higher Education.

He said that this bill is a result of needing a more qualified board to better review the licensing of these boards.

Senator Lamb asked if Mr. Anderson feels that the Board of Regents has enough to do.

Mr. Anderson stated that he is certain that they have plenty of work.

Senator Lamb asked if it is not the responsibility of the Board of Regents to oversee the quality of higher education.

Mr. Anderson stated that it is.

Senator Lamb stated that he is not certain that this transfer of responsibility is necessary; that it may place an unneeded burden on the Board of Regents.

Mr. Anderson stated that there have been three people on staff since 1976 on the Commission, and that they are in charge of licensing more than 100 higher education institutions in the State.

Senator Jacobsen asked if the Board of Regents are qualified to handle the transfer of responsibility if this transfer were to take place.

Mr. Anderson stated that they are; that someone must handle the full range of responsibility for licensure criteria.

Senator Jacobsen asked if he was correct in his understanding that the Veteran's Administration contributes funds to the Commission, and he also asked if this transfer were to take place, it if would jeopardize any federal funds that might be forthcoming otherwise.

Mr. Anderson stated that it would not, but he did indicated that the Federal funds from the Veteran's Administration had been cut in half.

Senate Committee on Finance May 25, 1981 Mr. Robert Cashell, Regent, testified that the Regents have no position on this bill one way or the other. He said that this is not the Regents' bill. Senator Lamb asked if the vocation programs at the community college level and on the University level were added under the Regents' discretion if this would create a conflict of interest. Mr. Cashell said that it could. Senator Lamb asked if Mr. Cashell feels that the Board of Regents has enough to do. Mr. Cashell says that they have plenty to do. Senator Lamb asked if anyone from the Board of Regents had heard any criticism of the Commission's performance. Mr. Cashell stated that they have not received any such complaints. Senator Lamb asked Mr. Anderson or Mr. Cashell to express an opinion as to where this opposition may be arising. Mr. Cashell stated that the problem originated with the Collete of Humanistic Studies. The Commission on Post Secondary Education had received complaints that the staff psychologists were not properly qualified to teach in the State of Nevada. He said that the original accreditation of the College had been achieved through its affiliation with another university, which, subsequently, had lost its accreditation. He said that the consensus was that the Commission had properly done its djob in licensing this institution. Mr. Anderson interjected a point of clarification; that there has been a problem with Novelle University, too. Senator Glaser asked with the proposed budget in this bill, how many schools will come under the auspices of the Board of Regents if this bill were to be passed. Mr. Cashell said that they would only be involved with approximately 10 to 13 schools with the Board of Education taking the balance of school.s Dr. John White, Education Officer at Nellis Air Force Base, told the committee that the Education Department at Nellis Air Force Base does not pursue any degree granting programs until they have cleared that the college is properly accredited and licensed under the CPE. Dr. White further indicated that it is his belief that if this bill is passed that Golden Gate College, a college which directly services the Air Force Base at Nellis, will drop its accreditation under the CPE and would only employ Department of Defense personnel to train the students. 4.

Senate Committee on Finance May 25, 1981 Audrey Aaron, Professor of Literature from Old College, spoke to the committee in support of defeat of this bill. She stressed that an autonomous board will help orivate colleges maintain an independence of action in regard to curriculum. She said that she feels that a State agency would do har in their construction of curriculum criteria, and she opposes this proposed transfer of authority. Mr. Robert Bersi, Chancellor, addressed the committee. indicated that he does not feel that this transfer is necessary, although the Chancellor's Office would be more than capable of handling this problem. -000-ASSEMBLY BILL NO. 501 Mr. Charles Wolff, Director of the Department of Prisons and Mr. Perry Comeaux, Assistant Director, presented this bill to the committee. They began by giving the committee a breakdown on this bill and indicating what it will provide to the prison system. Senator Lamb asked what the relationship is in this bill between \$156,000 and \$406,000. Mr. Comeaux stated that the Public Works Board has assured the Ways and Means Committee that they will have a balance of \$250,00 from the Capital Construction Fund to purchase the proposed equipment and supplies plus the amount of \$156,000 which is the amount of this appropriation. -000-ASSEMBLY BILL NO. 119 Mr. Ace Martelle, Director of Human Resources Department, and Mr. Jerome Griepentrog, Administrator of the Mental Hygience and Mental Retardation Division, gave the presentation on this bill. Mr. Griepentrog began by stating that this proposed legislation provides another deterent program to institutionalized care. He said that, in effect, this would provide extra services to keep a mentally retarded or mentally distrubed child from having to be institutionalized and would help keep the families of these children together by offering them assistance, both financial and in other ways. Senator Gibson asked if the grant has a cap of up to \$260.00 per month. Mr. Griepentrog replied that it does; that the full authorization of the grant would enable them to help service approximately 250 families. Senator Lamb asked how much money are these families receiving Mr. Griepentrog replied that there is no program such as this currently in existence. Senator Glaser asked if this program would augment any community care centers that may be serving the public presently. 5. 2701

Senate Committee on Finance May 25, 1981 Mr. Griepentrog replied that it would, but that it would be supplemental to the CTC Program. Senator Lamb asked what the current cost of institutionalizing one of these children is. Mr. Griepentrog said that the cost averages approximately \$36,000 dollars per year. Mr. Martelle said that that cost applies only to the severely mentally retarded, though. Senator Wilson asked if this grant would be allocated into a monthly benefit for the families involved. Mr. Martelle said that it would, but that they will have to develop the eligibility criteria for this program. Senator Gibson asked if it were a possibility if any of those individuals currently institutionalized would be able to return to their home environment because of the startup of this program. Mr. Griepentrog replied that that would not be so; that this is only a preventative measure for the future. Senator McCorkle stated that he feels that \$260 dollars per month is too small a figure. Senator Lamb stated that he would like to see this figure raised also. Senator McCorkle asked Mr. Martelle what they are recommending. Mr. Martelle said that right now this bill is capped for both fiscal years, but he added that he would prepare a recommendation for the Committee by this afternoon. -000-Mr. Del Frost, Director of Vocational Rehabilitation, spoke to the Committee about the concerns he has with regard to the personnel cutbacks as proposed by the Ways and Means Committee. He said that there are conflicts created by these cutbacks with the agency's charter. He indicated that he could live with all cutbacks proposed except those made in the personnel area. -000-Senator Gibson asked Mr. Martelle if he had anything to report on the Henderson Mental Health Center. Mr. Martelle said that Assembly Ways and Means stated that they would endorse the Senate Finance recommendation on this institution. -000-There being no further business, the meeting was adjourned at 8:59 a.m. -000-

Senate Committee on Finance May 25, 1981 The meeting of the Senate Committee on Finance was reconvened at 5:30 p.m., on Monday, May 25, 1981, in Room 231 of the Nevada State Legislature Building, Carson City, Nevada. ASSEMBLY BILL 437 This bill was presented by Mr. Alan Glover, Assemblymen for Carson City. Mr. Glover stated that the original of this bill requested that the State pay all group insurance benefits for State employees. He said that they have increased their request over the \$15 dollars by \$3 dollars the first year and \$5.70 the second year, which will aid retirees' insurance benefit payments. Senator Lamb called attention to line 12 of the bill and questioned whether or not the practice of making a direct legislative appropriation is a valid practice any longer. Mr. Sparks said that it is not a valid practice any longer; that the method of funding this legislation would have to be changed making the funding source a payroll assessment. Mr. Barrett said that the fiscal impact of the bill is \$38,340 dollars the first year and \$71,748 dollars the second year of the biennium. -000-ASSEMBLY CONCURRENT RESOLUTION 45 Mr. Ted Sanders, Superintendent of Public Instruction, presented this bill to the Committee. He said that this bill would set up the vehicle to act as a secondary market to purchase student loans. He said if the lending institutions will follow this program, it would make available an extra \$2 million to \$3 million dollars for the next year of the biennium, making the total amount of dollars available in the area of \$8 to \$10 million dollars. He said that the three primary institutions in the State of Nevada which have been participating in this program are First National Bank, Valley Bank and City Bank of New York. Senator Gibson asked what the net effect of the passage of this legislation would be. Mr. Sanders stated that it is part of the intent of the bill to make more money available for student loans; that he feels that this will make more money available to students as money becomes tighter in the future for student loans. He said that through City Bank's ability to repurchase these student loans from local banks, it will create a secondary market for students in the State. Senator McCorkle asked why the Sally Mae stock is insufficient to buy out the current student loan program. Mr. Sanders replied that the growth of the program has placed an unwieldy burden on Sally Mae stock to such a point that it cannot handle the demand. -000-2703 -7-

Committee on Finance May 25, 1981 ASSEMBLY BILL 587 This bill was presented by Mr. Tom Hickey, Assemblymen, and Dr. Ralph Young, Director of Agriculture Experiment Station at the University of Nevada, Reno. Mr. Hickey stated that this watering system will increase the yield and quality of the plants under this sytem with a 50 percent water savings. He said that, as yet, no successful system of watering lawns has been developed; that this is one of the main goals this study will hope to accomplish.

He said that if they can develop the equipment to adapt
this system for urban plant care, including ornamental plants
and lawns, then it will mean drastic reductions in water
consumption. He also indicated that Lincoln Properties Company has expressed the desire to joint venture this project with the University. Senator McCorkle asked which study -- the "drip" irrigation system study or the water recharge study -- has greater priority. Mr. Hickey replied that the recharge study impacts the groundwater basin levels while the "drip" irrigation study would impact the rangelands and farmlands. said that the "drip" irrigation study would be beneficial to the water shortage problem in large urban areas; that this is a water delivery system study. Dr. Young then addressed the Committee, expressing his support of this system and the necessity of conducting this study. He also indicated that many of the agricultural organizations heavily endorse this study. Senator Glaser asked why it was necessary to fund this study at \$150,000 dollars and asked if they could not get along with a smaller appropriation. Dr. Young replied that they will make the study fit the appropriation, but he feels that too drastic a cut in the appropriation will hamper their ability to do a proper He said that the least that they could get by with is \$50,000 dollars. Senator Glaser expressed the desire to pare back this appropriation in order to be able to conduct both studies. Mr. Ken Redelsperger, Assemblymen, stated his support of this bill and stressed that the real application of this system will be in urban areas and those areas with water problems. -000-ASSEMBLY BILL 696 Mr. Kenneth Partridge, Vice Chancellor for Finance for the University of Nevada System, gave the presentation on this bill. He briefly explained the financial impact of this bill. Senator Lamb stated that in increasing the mileage allowance and the per diem the Committee should attempt to be consistent across the board. Mr. Partridge stated that he believes that the Board of Regents has always enjoyed a per diem at least \$1 to \$2 dollars higher because of the fact that they are not 2704 -8-

financially compensated for their time.

Senator Lamb asked Mr. Partridge if he was aware of the Board of Regents sentiments about Senate Bill 587.

Mr. Partridge stated that he is not able to comment on that question.

SENATOR JACOBSEN SECONDED THE MOTION. THE MOTION CARRIED UNANIMOUSLY. -000-Senator Echols then distributed a proposed amendment to the language which appears in Subsection 2, line 1. SENATOR GIBSON MOVED TO AMEND THE LANGUAGE IN SUBSECTION 2, LINE 1, AS FOLLOWS: "Commission may use deposit to recover regulatory expenses and shall credit the deposit toward payment of the tax. amount of the credit shall be limited to the amount of the deposit used." SENATOR JACOBSEN SECONDED THE MOTION. THE MOTION CARRIED UNANIMOUSLY. -000-SENATE BILL 429 Senator William Raggio gave the presentation on this bill. He said that presently the time-share industry is not fully regulated in the State of Nevada; that the time-sharing industry is increasing, and that he feels that in the future it will become a major industry in the State. Senator Raggio went on to cite many of the problems with the lack of regulation of the time-share industry, especially as it affects sales to perspective purchasers of real estate. He stated that he feels that the time-share industry will greatly boost the purchase of vacation-type facilities where there is a promise of no increased fees or expenses. He said that this will also encourage out-of-State purchases and will help to stimulate the economy. Senator Lamb asked Senator Raggio to better explain the fiscal note attached to the bill. Senator Raggio indicated that the figures in this bill were developed by the Real Estate Division. He said that they are proposing a staff of three individuals, together with the fringe benefits. He said that this portion will cost approximately \$50,595 dollars plus the additional equipment to be supplied and the rental space, the total appropriation needed would be \$58,625 dollars. He said that the Real Estate Division feels that this appropriation would be repaid by the generation of fees which have been included in the bill, (please see Section 67). 2706 -10Senate Committee on Finance May 25, 1981

Senator Raggio said that the registration fee was based on a projected number of applications for time-sharing (50 applications) at a cost of up to \$2,500 per registration fee. He also indicated that there have been other amendments made to the bill, but they have no fiscal impact.

Senator McCorkle asked if there was any rationale to the fee being greater than the cost of subdivision.

Senator Raggio replied that they are going to try this proposal for two years, and if it has not proven itself fiscally sound or if the fee seems to be too excessive, then they will reexamine the proposed legislation.
