MINUTES OF THE MEETING OF THE SENATE COMMITTEE ON FINANCE

SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE May 27, 1981

The Senate Committee on Finance was called to order by Senator Floyd R. Lamb, Chairman, on Wednesday, May 27, 1981, at 8:00 a.m., in Room 231 of Nevada State Legislative Building, Carson City, Nevada. <u>Exhibit A</u> is the Meeting Agenda. <u>Exhibit B</u> is the Attendance Roster.

SENATE BILL NO. 631

Senator Lamb requested further testimony on this bill from Mr. Rick Kuhlmey, Volunteer Lobbyist, prior to the committee taking any action on this bill.

Mr. Kuhlmey stated through the passage of this legislation, the blind and deaf will obtain better services and will create a more responsivel administration.

Mr. Sparks asked if the present administration, i.e., Mr. Ace Martelle, Director of the Department of Human Resources, and Mr. Del Frost, Director of Vocational Rehabilitation, are still taking the position that it would be illegal to split the administration of this department according to federal statutes.

Mr. Kuhlmey said that they are taking the same position.

Senator Jacobsen asked what would happen if this bill is not passed.

Mr. Kuhlmey stated that he feels that Services to the Blind will greatly deteriorate.

Senator Jacobsen asked how many states are providing this concept of services to the blind and deaf.

Mr. Kuhlmey stated that Colorado and Alabama have this system on-line and Northern California has a pilot project going. He indicated that Alabama and California do not provide this service as part of their statutes but Colorado is.

Senator Echols stated that he feels this is a perfect place to utilize volunteerism from the community.

Mr. Kuhlmey stated that they did keep this in mind when drafting this legislation; that volunteers would be able to provide some administrative assistance. He said that drafted into the body of the bill is a provision which would mandate that volunteers become subject to laws of confidentiality.

Senator Wilson asked what is wrong with the present services provided by the Department of Vocational Rehabilitation.

Mr. Kuhlmey stated that the deaf and blind are in great need of specialized and unique services that it is more costly and more time consuming to rehabilitate these individuals. He said that counselors in the Rehabilitation programs are frustrated in trying to rehabilitate these individuals because they are pressured to maintain a certain rate of rehabilitation success with each of their clients.

Senator Wilson asked why the Rehabilitation Division does not change their policy where these individuals are concerned.

Mr. Kuhlmey stated that the Rehabilitation Division has organized their program in such a way that it does not allow for the needed changes that would be necessary to alter the picture for the deaf and the blind. He also said that the Bureau of Vocational Rehabilitation has been handling the rehabilitation of the blind and the deaf since 1973, and the consensus is that they are not receiving proper help.

ASSEMBLY BILL 677

Mr. Sparks told the Committee that this bill would provide for an increase in group insurance premiums from the current level -- \$67 dollars per month -- and over what the Governor has proposed as an increase -- \$74 dollars per month for the first year of the biennium and \$81 dollars per month for the second year of the biennium -- to Senate Committee on Finance May 27, 1981

\$75 dollars per month for the first year of the biennium and \$90 dollars per month for the second year of the biennium. He said that this would amount to a total increase for both years of the biennium of \$800,000, which would be mostly effective in the second year of the biennium.

SENATOR GLASER SECONDED THE MOTION.

THE MOTION CARRIED UNANIMOUSLY.

ASSEMBLY BILL NO. 677

Mr. Robert Gagnier, Executive Director of SNEA, came before the committee to more fully explain the fiscal impact of this proposed legislation. He informed the committee that this bill has passed the Assembly Ways and Means Committee just today, and he proceeded to give the committee a brief historical background on the bill.

Mr. Gagnier told the committee that the State employees could live with a 10% increase the first year of the biennium, but not for the second year, also. He stated that this legislation proposes an increase of 12% the first year and 20% the second year of the biennium. He further indicated that 12% is the minimum increase that is acceptable.

Senator Lamb asked for the total figure on this legislation.

Mr. Barrett replied that in the first year of the biennium, the cost of this legislation would be approximately \$200,000, with a \$100,000 share from the General Fund, and in the second year of the biennium, the total cost would be \$650,000, with a \$325,000 share from the General Fund. He said that the total figures quoted are figures that are computed above what the Governor has recommended.
