## MINUTES OF THE MEETING OF THE SENATE COMMITTEE ON FINANCE

## SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE May 4, 1981

The Senate Committee on Finance was called to order by Senator Floyd R. Lamb, Chairman, at 8:00 a.m., on Monday, May 4, 1981, in Room 213 of the Nevada State Legislature Building, Carson City, Nevada. Exhibit A is the Meeting Agenda. Exhibit B is the Attendance Roster.

The meeting of the Senate Committee on Finance was called to order by Senator Floyd R. Lamb, Chairman, at 8:00 a.m.

Senator Lamb directed Mr. Ronald Sparks to read two letters which had been sent to the Committee via Senator Lamb. The first of these two letters was from Mr. John L. Meder, Director of the State Parks Division, (please see <u>Exhibit C</u>). The second of these two letters was from Mr. William Hancock, Department of Prisons, (please see <u>Exhibit D</u>).

Mr. Barrett said that all three major prison facilities are encountering problems with their utilities and a zoning problem at the Southern Desert Correctional Center. He said that the Bureau of Land Management has granted the prison permission to operate with a prison population of 600 prisoners. He said that if the State were proposing to expand this facility and provide additional beds, then the State would have to obtain a variance from the Bureau of Land Management in order to do so.

Senator Wilson asked Mr. Barrett if the Committee is obligated to make some sort of commitment as to Capitol Improvement prior to the adjournment of this Legislative Session. Senate Committee on Finance May 4, 1981

Mr. Barrett replied that only in a broad manner is the Committee expected to make any Capitol Improvement planning decisions. He indicated that if there were any monies to be appropriated, then the administration would come before Interim Finance as to the actual dollar amounts needed and the actual location of either the expansion of the present system or the new construction of a prison.

Senator Wilson asked for a clarification of what Mr. Barrett meant by "in a broad manner."

Mr. Barrett said that they are requesting \$150,000 for planning, and with the Board of Examiners' approval, to sell up to \$20 million dollars in bonds for prison capitol improvement, the specifics of which will have to be approved by Interim Finance. This would consist of additional construction and additional beds.

Senator Lamb stated that this will not solve the problem; that it is only a stop-gap measure, if the current trend holds. He also stated that he wants to see the State move ahead of the problem and not be swallowed up by it.

Mr. Barrett said that if the Committee were to elect to wait until next session to act, there would be no greater problem then than there is now; that there will be no greater quantity of double bunking than there is now.

Senator Lamb asked what would happen if the Federal Court were to hand down a ruling to disallow double-bunking.

Mr. Barrett replied that then the State would be in very serious . difficulty.

Senator Wilson asked if Mr. Barrett concurred with Mr. Hancock's prediction in his letter that the present zoning and water supply problems raises serious questions about the feasibility of expanding the present prison system.

Mr. Barrett replied that he does; that the prison administration had no idea how many more people the present water and sewage systems will support. Mr. Barrett indicated that this is the basis for the request of \$150,000 to support a study to find out whether or not an expansion program is feasible or whether this will require new construction. This will enable them to come before Interim Finance and make a concrete recommendation.

Senator Lamb asked Mr. Barrett, if he were either the Public Works Board or the Prison Department, wouldn't he have a handle on what could be done with each facility.

Mr. Barrett agreed.

Senator Wilson asked why this request for \$150,000 for a study is being made so close to the end of the session.

Mr. Barrett indicated that there are two proposals in the Capitol Improvement budget which would be sufficient until the next biennium.

Senator Wilson said that he feels the tardiness of this proposal is irresponsible and indicated that he was not holding Mr. Barrett Senate Committee on Finance May 4, 1981

at fault for this late request.

Senator Lamb asked the committee what their priorities are in respect to the welfare of the people of the State of Nevada. He stated that he believes education is first and public saftey comes second.

Senator Glaser replied that he agrees with Senator Lamb's priorities; that if the prisons were properly secured, the State might have more money to allocate to education.

Senator Lamb said that with the coming of the MX Missile, there will, more than likely, be an expansion in the prison population. He requested that the Governor come before the Committee and be joined by Mr. Wolff, Director of the Department of Prisons and Mr. Hancock, to talk to the committee about this problem.

During the current biennium, State Parks was authorized to spend \$500,000 of Motor Boat Fuel Tax money for park improvement projects (Statutes of Nevada 1979, Volume I, Chapter 485). In addition to that, \$18,672 was collected and placed in the State Park account. We had planned to spend that additional money on access improvements to the Churchill Beach area at Lahontan State Recreation Area. However, the Budget Office after conferring with Frank Daykin, Legislative Counsel, advised us these funds could not be spent until legislative authorization was given.

We would appreciate your support for authorization to allow State Parks to spend the additional \$18,672 for the purpose of paving the entrance way to Churchill Beach. Since the Park Improvement Bill, SB 276, has not been acted upon, it might be possible to amend it to allow for the expenditure of the additional Motor Boat Fuel Tax money.

Your help with this important matter will be greatly appreciated. If you have any questions or need additional information, please let me know.

Dear Senator Lamb:

We share your expressed concerns about prison planning.

In March of this year, upon learning of the wide variety of new and costly proposals being considered to realize major increases in prison capacities, we recommended the attached planning program to the Department of Prisons. In my opinion, this program is necessary since I am not at all sure that it is either feasible or legal to significantly expand any of the existing prisons due to possible utility and zoning problems. If additional capacities are needed, new institutions may have to be considered.

The projections currently being used to justify the need for the major expansions were not available to the Board when it developed the recommended 1981-83 CIP and the prison's requests for improvements did not include any requests for additional capacities beyond that recommended by the Board. At that time prison population projections indicated that with the completion of the approved and recommended housing, the 1983 prison population and 1983 prison design capacities would be within 5% of each other.

The recommended planning program would take about six months to complete and cost approximately \$150,000. If the funds now being considered for prison expansions could be appropriated and "escrowed" pending completion of the planning program, I don't think there would be any significant delay in realizing any essential improvements.

I recommend your support of the planning program.

Our budget request for this account can be reduced to \$22,000 based on the following plans:

A. Plant trees and shrubs along Glendale Avenue from Galletti Way to 21st Street, Sparks. This work to be done by State Division of Forestry. Prison labor will be used and plants will come from the Forestry nursery. Estimated cost of this work: \$2,000.

B. Plant approximately two acres of lawn along the south side of the Nevada Mental Health Institute and the Sierra Developmental Center campus. This will include the installation of a sprinkler system. Prison inmate labor will be used where feasible. Estimated cost of this work: \$20,000.

Authority is requested to accomplish the above described work, without going through the Public Works Board as a Capitol Improvement Project. The Public Works Board estimate for accomplishing this work was \$50,000.

## **RE: DISTRICT JUDGES EDUCATION**

In response to the inquiry of Senate Finance regarding funding of district judges education through an increase in filing fees, the following information is provided:

Noncriminal filings in the district courts of Nevada for calendar year 1980 were 35,864. This is further broken down into civil (13,460), domestic (19,441), probate (2,350), and other (613). If the civil category alone is used (this includes tort, property, contract & debt) then an increase of \$2.00 would provide revenues sufficient to support a program as outlined in our testimony. If all noncriminal filings are included, then an increase of \$1.00 would support a program better than that outlined at the hearing. With the additional money, more judges could receive continuing education sooner.

SUBJECT:	Recommendations for Interim Fire Protection Methods State Archives

The best and proven method of protection of life and property from fire loss or damage is a fixed, automatic fire extinguishing system. If that is not possible to obtain on a short term arrangement, there are some things which could be done to minimize damage from fire as opposed to automatic extinguishment. The following recommendations are not a substitute for an automatic extinguishing system. They will merely lessen the overall impact of a fire.

OPTION #1 - Additional Smoke Detectors

- A. Additional smoke detectors should be installed. One in the vault, one each in the administration ground floor corridor and the upstairs office area corridors.
- B. Two additional zones should be added to the annunciator panel. One each for the vault and the administration building (lst & 2nd floor). NOTE: This will allow an earlier report of fire anywhere in the structures to the fire department, which is relatively close, and reduce the possibilities of a deep seated major fire.

OPTION #2 - Compartmentalize the Storage Addition

- A. Seal all openings (windows, pipe holes, exterior doors & windows, etc.) in the existing fire walls. These walls separate the storage addition into three major areas and a small area vault.
- B. Install three automatic closure fire doors in the interior wall's door openings.
- C. Convert the existing fusible-link fire door between the storage addition and the Administation Building to automatic closure.
  - D. Connect all automatic door closures to the smoke detector alarm.
- E. Install an approved metal-clad fire door at the loading ramp exit of the storage addition. (Seal the other adjacent doorway)

F. Replace the storage addition exterior wall windows with wire-glass or seal the window opening.

NOTE: Upon activiation of any smoke detector, all doors in the storage addition would close and provide a fire resistive compartment to confine the fire to either the Administration Building or the storage compartment of origin.

An exterior fire (auto or other) would provide a minimal threat to the interior with approved doors and windows.

OPTION #3 - Automatic Extinguishing System - Partial

- A. Install a water sprinkling system in the first and second floor of the Administration Building.
- B. Connect present fusible-link fire door separating the Administration Building from the storage addition to the sprinkler flow alarm.
- C. Extend the sprinkler flow alarm to the fire department.

NOTE: The most probable area for a fire to begin is the that area most often used for human occupancy. In this instance it would be the two story Administrative Building. Sprinklering this area would reduce the possibility of a fire in that area extending into the storage area.

OPTION #4 - Enclose Rack Storage

A. Purchase or construct metal enclosures for each rack of stored archives. There are 292 units or racks which are approximately 7 ft. high, 1½ft. wide and either 36 or 42 inches wide. These units are compounded back to back and end to end to form rows 7 ft. high, 3 ft. wide and various lengths to best use the space available. The enclosures would have door openings as needed and be treated for acid resistance. Each row would be enclosed in a fire rated metal enclosure.

NOTE: Such enclosures are available but this office has no outlet to check on the costs of a unit as rated class D - (Class 350-1 Hr.) as per National Fire Codes 232-415. This type enclosure would protect the interior archives from an exterior fire and contain an interior fire until the fire department arrived.

OPTION #5 - Any or all of the previous recommendations could be incorporated together to make the State Archives less susceptible to the loss by fire.

The new total for fiscal year 81-82 is \$477,526 and for fiscal 1982-83 is \$523,536. These figures are adjusted because of the estimated salary increases. The total salary for the first year is \$47,227 with a salary adjustment figure of \$7,146. The second year the total salary is \$50,620 with a salary adjustment figure of \$9,337. Additionally the \$1,000 of operating was allocated among all three agencies as follows:

\$696 increase to DDC
\$76 increase to CBS
\$228 increase to Las Vegas Mental Health

for the new totals which were previously indicated. The new totals

for DDC for the first year's revenue is \$344,245; for the second year, \$376,320;

for CBS for the first year's revenue is \$32,926; for the second year, \$36,349;

for LVMHC for the first year's revenue is \$100,355; for the second year, \$110,867.

In addition to effect on the food center budget it is imperative that we notify Mr. Sparks and Mr. Bible to change the Las Vegas Mental Health Center budget, CBS budget and DDC budget to reflect the above figures.
