Dear Governor List:

In closing the Department of Prisons' 1981-83 biennial budget, the Senate Finance and the Assembly Ways and Means Committees want to clearly express their concerns over the level of security at the Nevada State Prison.

In the budget review process, both Committees spent many hours in Subcommittee, Committee, and Joint Committee review of the Department of Prisons proposed budgets as well as the supplemental requests generated from the Jerry Enomoto report of April 15, 1981.

The Committees' considerations included a review of the legislatively approved staffing budgets for the Department for the current (1979-81) biennium. That review centered on the 31 new correctional officer positions authorized at the Nevada State Prison for fiscal year 1980-81. As you know, the 1979 Legislature approved those positions based on anticipated post coverage at the renovated Maximum Security facility. These post assignments, as explained to the Legislature, included staffing the new Maximum Security housing units with two officers on two shifts and one officer on the graveyard shift in each unit and staffing for a new gun tower (which was never constructed) between the old and new institutions. The housing unit staffing configuration recommended in the Enomoto Report is the same as that approved by the 1979 Legislature.

The 1979 Legislature also provided the Department the authority, in Section 61 of the 1979 General Appropriations Act, to transfer funds among the various budget accounts within the Department subject to the approval of the Interim Finance Committee. The Department used this transfer authority at the August 25, 1980, Interim Finance Committee Meeting and transferred 16 of the newly authorized 31 correctional officer positions to other insti-


tutional budgets to provide new post coverage. Apparently, at that time, the Department of Prisons assigned a higher priority to these positions in other institutions rather than retaining them at the Nevada State Prison. In requesting the transfer of these positions, however, the Department never fully explained the impact this would have on the staffing configuration at the Nevada State Prison.


These impacts have only become apparent as a result of the legislative decision not to increase the correctional officer complement at the Nevada State Prison over the number requested in the Executive Budget. Mr. Enomoto, during the Legislative Session, indicated the need for a number of correctional officer positions in the Nevada State Prison.

This letter is intended to indicate the money committees' intent that the 16 positions that were transferred from the maximum security institution at the August 25, 1980, meeting may be returned to that institution to provide the necessary security, if, in the determination of the Administration, that is the Department's top security priority.

The authority for future transfers among Prison budget accounts (subject to the approval of the Interim Finance Committee) has again been provided to the Department by the 1981 Legislature in Section 62 of A.B. 709 (the General Appropriations Act). This transfer authority has been retained by the Legislature to allow needed flexibility to accommodate changes in Prison policy. In the future, however, the impact of such transfers should be fully explored and the ramifications of those transfers should be considered prior to approaching the Committee for such transfers.

In closing the Attorney General's budget for the 1981-83 biennium, the Assembly Ways and Means Committee and the Senate Finance Committee added a new Deputy I for the Department of Conservation and Natural Resources which was not included in the Governor's recommendation. The expressed purpose for this additional position was to help strengthen the state's legal position should the Federal Government decide to locate MX in Nevada. Dear Chairman Cashell:

In closing the budgets for the University of Nevada System, the Assembly Ways and Means Committee and the Senate Finance Committee requested that their intent on a number of budget items be clearly expressed to the Board of Regents.


First, the Committees indicated that, should enrollments increase above the levels anticipated at the University and Community College campuses, the Board of Regents should approach the Interim Finance Committee for possible budgetary relief to accommodate the increased enrollments. Coupled with this action, was Committee approval of a provision in the Authorized Expenditure Act which exempts student fees from controlling language that requires a like amount of General Fund reversion in the event that the student fees increase over the anticipated levels.

Secondly, even though the Committees made a reduction in the School of Medical Sciences, they wanted the School to continue to emphasize family practice and rural medicine.


Thirdly, the two Committees approved language in the General Appropriations Act that makes release of appropriations for increases in professional faculty compensation in fiscal year 1982-83 contingent upon implementation of a faculty workload standard that averages 12 credit hours of instruction for each faculty member. The Committees indicated that they would be willing to have a small Interim Finance Subcommittee work with the Board of Regents in developing this workload standard so that the additional compensation can be provided for the professional employees of the University of Nevada System.

We look forward to working with the Board of Regents on these matters in the upcoming biennium and are confident that a stronger University System will result from a harmonious working relationship between the Board of Regents and the Interim Finance Committee.




Dear Bill:

As you know, S.B. 685 contains a \$150,000 General Fund appropriation for planning for prison facilities. In closing the budget for the proposed new Forestry Honor Camp at the Southern Desert Correctional Center, the Assembly Ways and Means Committee and the Senate Finance Committee unintentionally left in 100 percent of the Division's request for travel differential funds. In closing the budget for the Southern Desert Correctional Center, the two Committees reduced the requested travel differential funds by 50 percent in order to encourage Department of Prisons' employees to locate their residences near the Prison facility. To be consistent, the Committees should have reduced the Forestry Division's requested travel differential funds by 50 percent also. However, since this was not done, will you please isolate one-half of the travel differential funds which were appropriated and either revert it to the state's General Fund or apply it toward salary adjustment needs.


Also, in closing the budget for the Prison Honor Camp, income from the operations of the inmate crew was added as a revenue

source to offset General Fund appropriations. Since your Division initially collects these funds and also uses them to support the Forestry portion of the Honor Camp budget, would you please remit to the Department of Prisons, on a pro rata basis when comparing total authorized income in the two programs, its share of all collections that are made.





The Senate Finance Committee and the Assembly Ways & Means Committee, in closing the budget for the Comprehensive Statewide Planning Office, reduced state appropriations to the current work program level and balanced the office's budget with anticipated federal receipts. The Committees felt that non-state funds should continue to support much of the work of the State Planning Office and noted that substantial amounts of planning funds are anticipated through the operation of the MX Planning Office. In the event that these MX Planning Funds or other federal funds do not materialize, the two Committees felt that it would be appropriate for your office to approach the Interim Finance Committee for a possible allocation from the Contingency Fund.

The Committees' action is not to be interpreted as an open invitation for Interim Finance Contingency Funds and, should it be necessary, you should approach the Interim Finance Committee only after you have exhausted all possible non-state revenue possibilities and have developed an on-going budget which requires only a minimal amount of state support.


In closing the budgets of the Welfare Division, the Senate Finance Committee and the Assembly Ways and Means Committee added an Unannounced Home Visit Team to the Welfare Administration budget. It is the intent of the two committees that the Division report quarterly to the Interim Finance Committee on the results being obtained through this particular program.


In closing the Food Stamps budget, the two committees requested that the Division request waivers from the Federal Government on possible elimination of the Outreach Program.

In closing the Child Welfare budget, it is the intent of the two committees that the Division develop a procedure where clients pay, where feasible, the first \$5 per visit in the non-Title XIX Medical Program.

Also, in closing the Title XIX budget, the two committees adopted a spending plan that requires co-payment for all optional medical services and retains reimbursement rates to individual practitioners at fiscal year 1981 rates. In the later instance, if the Welfare Division so chooses, they should approach the Interim Finance Committee in late fiscal year 1982 to discuss the possibility of providing a rate increase to individual practitioners during FY 1982-83.




