#### MINUTES OF THE MEETING OF THE SENATE COMMITTEE ON GOVERNMENT AFFAIRS

### SIXTY-FIRST SESSION NEVADA STATE LEGISLATURE February 2, 1981

The Senate Committee on Government Affairs was called to order by Chairman James I. Gibson, at 2:00 p.m., Monday, February 2, 1981, in Room 243 of the Legislative Building, Carson City, Nevada. Exhibit A is the Meeting Agenda.

William D. Swackhamer, Secretary of State, was present to explain the following bills:

#### SENATE BILL NO 89

Deletes obsolete provisions regarding photocopy room of Secretary of State.

Mr. Swackhamer explained that there no longer was a photocopy room, thus all references to this were obsolete.

Senators Kosinski and Ford mentioned that there was little left of Nevada Revised Statute No. 225.110 when these photocopy references were deleted.

Mr. Swackhamer testified that Nevada Revised Statute No. 225.140 included provisions for charging governmental agencies.

Chairman Gibson suggested that Nevada Revised Statute No. 225.110 be repealed. He asked Mr. Swackhamer to reword

Nevada Revised Statute No. 225.140 to include the provisions for charging and make mention of microfilming. Mr. Swack-hamer will bring back a revised bill for committee consideration.

#### SENATE BILL NO. 90

Repeals obsolete reference to certification of nomination.

This bill would repeal Nevada Revised Statute No. 304.020. As written this statute is inoperative and outdated.

Senator K. Ashworth moved "Do Pass" on <u>Senate Bill</u> No. 90.

Senator Wagner seconded the motion.

The motion carried unanimously.

Chairman Gibson assigned Senator Wagner to answer any questions relating to this bill upon presentation to the Senate.

#### SENATE BILL NO. 91

Changing distribution of candidates' filing fees.

This bill would repeal Nevada Revised Statute No. 293.450. It states that the county clerk shall pay to the county treasurer all filing fees received by him from candidates. The county treasurer shall deposit the money to the credit of the general fund of the county. See Exhibit B for the amount of the total filing fees from the 1978 Election.

Senator Ford moved "Do Pass" on Senate Bill No. 91.

Senator K. Ashworth seconded the motion.

The motion carried unanimously.

Chairman Gibson assigned Senator Kosinski to answer any questions relating to this bill.

## BILL DRAFT REQUEST NO. 18-331 (S.B. 171)

Revises criteria used in legislative review of executive agencies.

# BILL DRAFT REQUEST NO. 23-458 (5.8.173)

Amends Airport Authority Act for Washoe County to authorize creation of a police department, adoption of a fire protection and prevention code and entitling police officers and firemen employed by the authority to early retirement.

# BILL DRAFT REQUEST NO. 28-249 (S.B.172)

Clarifies purposes for which engineering and architectural services of state board of public works may be used.

As there was no opposition, it was agreed to submit these bills for committee introduction.

Chairman Gibson stated that the committee would hear Senate Bills No. 75, 77 and 151 on Friday.

There being no further business, meeting was adjourned at 2:33 p.m.
