The following Bill Drafting Requests were discussed and received committee approval for introduction:

BDR NO. 16-649 (K. Ashworth) (S.B. 271)

Provides punishment for racketeering activities.

BDR NO. 2-701 (W. Raggio) (S.B. 249)

Permits admonishment of jury by officer of court other than judge.

BDR NO. 1-704 (W. Raggio) (S.B. 250)

Repeals provision regarding change of judge.

BDR NO. 11-181 (S.B. 251)

Revises provisions relating to parentage.

BDR NO. 11-183 (S.B. 252)

Strengthens provisions for assignment of earnings in child support cases and revises provisions for reciprocal enforcement of support.

BDR NO. 11-254 (S.B. 253)

Allows district attorney to assess fees against applicant for child support or establishment of paternity who is not indigent.

BDR NO. 14-554 (Wilson) (S.B. 248)

Establishes definite duration for civil commitment in certain criminal cases and provides for review and renewal by court.

BDR NO. 14-779 (S.B. 254)

Makes various provisions for discharge from parole and probation.

BDR NO. 14-781 (S.B. 255)

Revises certain provisions concerning violation of parole and probation.

BDR NO. 14-783 (S.B. 256)

Makes various changes in provisions regarding presentence reports.

BDR NO. 14-780 (S.B. 257)

Changes certain provisions on restitution by offenders to victims of crime.

BDR NO. 14-778 (S.B. 247)

Limits length of probation and use of presentence reports and provides for disposal of certain confiscated property.

BDR NO. 1-849 (W. Raggio) (S.B. 245)


Allows certain justices of peace to have partners who practice law.

BDR NO. 11-702 (W. Raggio) (S.B. 246)


Permits either spouse to bring an action for separate maintenance.
