#### PROPOSED AMENDMENT TO A.B. 527

#### OFFERED BY SECRETARY OF STATE DEAN HELLER

**April 1, 2003** 

Amend the bill as a whole by adding a new section to amend NRS 293.175, 293.387 and 293C.387 to move the primary election date to be held the 3<sup>rd</sup> Tuesday in August and to provide for the canvass to be held the 2<sup>nd</sup> Tuesday following the election, and amend the provisions addressing timing for requests for recounts, election contests and death of a candidate in conformance with these changes.

Amend the bill as a whole by adding a new section that provides that if a voter casts a provisional ballot for the wrong ballot, the provisional ballot shall not be counted.

Amend Section 3, subsection 2(h), page 2 by deleting line 24

Amend Section 7, page 3, line 43 by deleting the words [for a candidate for federal office].

Amend Section 7, subsection 1, page 4, line 2 by deleting the words [for federal office].

Amend Section 8, subsection 1, page 4, line 17 by inserting after the word "officer" as prescribed by the secretary of state.

Amend Section 8, subsection 1, page 4, line 39 by inserting after the words "voter that" if the voter does not provide identification at the time the voter casts the provisional ballot,

Amend Section 8, subsection 2(c), page 5, line 24 by deleting the words [only for federal offices].

Amend Section 9, page 5, line 26 by deleting the words [for federal office].

Amend Section 14, subsection 4, page 7, by deleting lines 43 and 44 and replacing the same with Instructions concerning the identification required for persons who registered by mail and are first time voters.

Amend Section 17, subsection 3, page 9, lines 25 through 27 by deleting the words [may use any file or list of registered voters maintained by his office] and deleting the words [or any facsimiles of voters' signatures], and replacing the same with the word must on line 25 after the words "county clerk".

Amend Section 20, subsection 3, page 11, line 24 by deleting the word "shall" and replacing the same with "is encouraged to"

Amend Section 25 subsections 4 and 5, page 15 and 16 to insert the word "Nevada" prior to all references to the Department of Motor Vehicles.

Amend Section 44, page 27, line 21 to delete the reference to [NRS 338.143] and replace with Chapter

Amend Section 45, subsection 3, page 27, line 31 to add after the word "purposes" unless the State applies for a waiver as provided in Section 303(d)(1)(B) of HAVA, in which case Section 3 of this act becomes effective on January 1, 2006 for all other purposes.

Amend Section 45, page 27 to add a new subsection that states the provisions of Section 20, subsections 3 and 4 and Section 35, subsections 3 and 4 become effective on January 1, 2006.

# PROPOSED AMENDMENT TO A.B. 529 OFFERED BY SECRETARY OF STATE DEAN HELLER

## **April 1, 2003**

Amend the bill as a whole by adding a new section that: (1) requires electronic filing of contribution and expenditure reports be mandated for all filers; and (2) requires contributions of \$1,000 or more to be electronically reported to the Secretary of State within 24 hours of receipt of the same.

Amend Section 3 to delete all references to NRS 294A.125.

Amend Section 4, page 3, subsection 1 at line 12 by adding after the word "election" and every elected official who is not also a candidate.

Amend Section 4, page 3, subsection 1 at lines 13 and 14 to delete [that the provisions of this subsection apply to the candidate]

Amend the bill as a whole by deleting Section 5, pages 5 and 6.

Amend Section 8, page 13, subsection 1, at line 36 by adding after the word "election" and every elected official who is not also a candidate.

Amend Section 8, page 13, subsection 1 at lines 37 and 38 to delete [that the provisions of this subsection apply to the candidate]

Amend Section 14, page 26, subsection 1, at line 16, by adding after the words "general city election" and every elected city official who is not also a candidate.

Amend Section 14, page 26, subsection 1 at lines 19 and 20 to delete [that the provisions of this subsection apply to the candidate]

Amend Section 21, page 31, subsection 1(a), line 18, by adding after the word "elected" or appointed.

Amend Section 23, page 32, subsection 1, line 36 by adding after the words "public office" is entitled to receive compensation for the office he or she is seeking.

Amend the bill as a whole by deleting Section 24

Amend Section 25 of the bill to mirror NRS 294A.420.

Amend Section 26 of the bill to also repeal NRS 294A.125
