Amend section 1, page 2, line 2, by deleting "14," and inserting "15,".

Amend section 2, page 2, line 4, by deleting "14," and inserting "15,".

Amend section 8, page 4, by deleting lines 23 through 27 and inserting:

"2. Upon request of a using agency, the local government shall prepare and issue a request for qualifications to not less than three qualified service companies.".

Amend section 8, page 5, line 23, by deleting "audit." and inserting "audit if the local government specifically appropriated money for that purpose.".

Amend the bill as a whole by renumbering sections 10 through 30 as sections 11 through 31 and by adding the following as section 10:

"Sec. 10. Notwithstanding any provisions of sections 2 through 15, inclusive, of this act to the contrary, a performance contract entered into pursuant to sections 2 through 15, inclusive, of this act must include a clause that sets out the rights of the local government and the qualified service company if the local government does not appropriate sufficient money for payments to be continued under the performance contract."
