Dear Committee:

I have had the good fortune to represent Elsa and James Heird in litigation surrounding the unfortunate, untimely death of their daughter Danielle. Without getting into the specifics of the litigation which is currently ongoing, I will simply state that Danielle was provided the drug Ecstasy by a friend and/or acquaintance who also took the drug. Danielle subsequently became ill and the person that provided the drug to her knew that Danielle was ill and that she had taken the drug Ecstasy. Despite having that knowledge, this individual did nothing to assist Danielle, but instead took Danielle to his home, along with Danielle's boyfriend, where they left Danielle so they could continue partying at clubs in Las Vegas.

It is my belief that had this individual and/or individuals assisted Danielle in ascertaining proper medical attention, that Danielle would be alive today. It is also my belief that Assembly Bill No. 443 would facilitate medical attention for those that have been sold or provided controlled substances such as Ecstasy and became ill.

Danielle's parent, James and Elsa, have, through their own personal tragedy, garnered national attention on Ecstasy use by the youth of this country. Through their heroics, millions of television viewers and newspaper followers have been enlightened regarding the potential deadly effects of Ecstasy. Assembly Bill No. 443 is the next step in protecting society as a whole and specifically the citizens of the great state of Nevada against the potentially deadly ramifications associated with substance abuse. No law can ever bring back the Heird's daughter Danielle, but there can be little doubt in rational thinking minds that Assembly Bill No. 443 will assist others like the Heirds from being devastated as they have been.


