In the event that a representative of the National Rifle Association may not be able to attend the Tuesday, March 25 hearing on your measure, AB 115, we would like to be on record as supporting an amendment that would direct the proceeds from the sale of the Second Amendment license plates to a scholarship fund for the purpose of educating the children of Nevada's slain law enforcement officers, should the need arise.

As we have indicated in previous communication, our foremost desire is to see the funds used for firearms safety and education training programs throughout the state. However, should this language no longer become an option, and the successful passage of the measure depend upon the afore-mentioned amendment, we would continue to be in support.
