A.B. 158	Directs Legislative Commission to conduct interim study concerning classification of peace officers.	Hearing held on 4/29/03 in Assembly EP&E; no action.
A.C.R. 10	Directs Legislative Commission to conduct interim study of operations of Public Employees' Benefits Program.	Adopted by Assembly on 5/22/03; to Senate.
A.C.R. 14	Directs Legislative Commission to conduct interim study of all elections, ethics, and campaign practices to find conflicting, outdated, or unnecessary provisions.	Discussion only on 5/1/03 in Assembly EP&E.
A.C.R. 18	Requires interim study of juvenile justice system.	Discussion only on 5/13/03 in Assembly EP&E.
A.C.R. 19	Directs Legislative Commission to conduct interim study of telecommunications services in Nevada.	Hearing set for 5/17/03 in Assembly Concurrent C&L; not heard.
A.C.R. 27	Directs Legislative Commission to appoint interim committee to study business practices of the automobile insurance industry.	Hearing set for 5/22/03 in Assembly EP&E.

S.B. 292	Directs Legislative Commission to appoint subcommittee to study impacts of recent privatization of industrial insurance program.	Pending receipt of amendment in Senate LA&O.
S.C.R. 21	Directs Legislative Commission to conduct interim study concerning reconfiguration of school districts in this state.	Pending receipt of amendment in Senate LA&O.
S.C.R. 31	Directs Legislative Commission to conduct interim study of feasibility of magnetic levitation train connecting various urban and rural communities in Nevada.	Heard in Senate LA&O on 5/13/03; no action.
S.C.R. 32	Directs the Legislative Commission to conduct interim study of criminal justice system in rural Nevada.	Pending receipt of amendment in Senate LA&O.
S.C.R. 37	Directs Legislative Commission to conduct interim study of geexchange technology	Heard in Senate LA&O on 5/13/03; no action.
S.C.R. 38	Directs Legislative Commission to conduct interim study of transitional housing for released offenders.	Pending in Senate LA&O; hearing not yet scheduled.
