LVMPD RATIO OF OFFICERS TO POPULATION

The following ratios are based on 1 officer per 1000 population.

These figures **DO NOT** take into consideration the more than 36,000,000 tourists per year.

The national average is 2.5 officers per 1000 population

The ratios are based on authorized, not actual number of officers.
(The City of Las Vegas and Clark County have required us to maintain a 2% vacancy factor.
Because of this we are not fully funded for our total number of authorized positions.)

- 1. Senate Bill 334 would give us the ability to adequately provide services to our rapidly growing jurisdiction
 - •increases in population as well as our service areas, large convention and tourism
 - •these are growth areas we have no control over
- 2. There are constantly increased demands on the available resources of our funding agencies.
- **3.** SB334 provides us with an alternative if it becomes necessary to seek additional funding.
- **4.** The Bill would allow us to respond to the public safety needs of our community in a timely way.
- **5.** SB334 would give us the ability to react to current conditions potential threats or significant events as they occur rather than 3 to 4 years later.
 - •the current process causes a 2 year delay.
- **6.** By eliminating the legislative step and enabling us to take a proposal directly to: •Fiscal Affairs Committee then;

- to the full City Council and County Commission;
- Debt Management
- •and then make our case before the voters within our jurisdiction
- 7. The Las Vegas Metropolitan Police Department would still be required to obtain approval from more levels than any other local government.
- 8. Without passage of this Bill Metro Police must anticipate;
 - •the law enforcement needs of the community
 - •gauge the fluctuating national and local economic conditions,
 - •gauge the ability of our taxpayers to fund a potential increase,
 - •more than two years in advance of a property tax initiative and three or more years before the revenue would actually materialize.
- 9. When you add the months it takes to recruit, screen, train officers and finally assign them to needed and vacant positions it adds another full year.
- **10.** Mr. Chairman, Committee members. As you can see by the officer to population ratios in the table we are losing ground. With the population in southern Nevada growing at 65,000 people per year the situation is bleak.
- 11. The delay the current process requires can put citizens, the business community and the officers in a dangerous and possibly life-threatening situation.
- **12.** Sheriff Young and the Metropolitan Police Department asks your support on the legislation.
